19	ROH, Harm Or Neglect Issues: <i>N/f Grant Davies has been the subject of Parramatta JIRT investigation in relation to numerous indecent sexual assaults of s/c 1-A3CBQB. Subsequently allegations against Grant Davies have been substantiated and he has been noted as PCH to s/c 1-A3CBQB. See plan 1-A9078S.</i>	Details in comments

**Section 29** *it has been assessed that there has been more than 1 victim of Grant's indecent sexual assault. However only s/c 1-A3CBQB has been willing to be i/vd by JIRT, with s/c 1-A3CBNE providing a written statement only to Burwood Police.*

*Indecent assaults included:*

- *grabbing the breast of s/c 1-A3CBQB, and moving them about whilst supposedly adjusting her bra during a dance competition.*
- *Making the children bend down with their bottom's sticking up supposedly to check that the children's leotards were on correctly*
- *making sexual comments to girls at the dance school, and conversing with them on the internet about sexual matters*
- *masturbating whilst he is talking to a child on the internet*

**Section 29** *identified Grant Davies obvious grooming process of his victims i.e. befriending the child, making her feel special, gradual escalation of 'touching' and threats of not being given roles in dance productions and being made to work harder in class, if child distances herself from Grant's advances.*

*There is an ongoing Police/JIRT investigation and the matter has been referred for legal advice. Police have also seized his computer, which has been sent to SEEB (State Electronic Evidence Branch) for IT forensic examination.*
