BZN contacted Parramatta JIRT and spoke with Srgnt Leanne O'Meara.

- BZN informed the Srgnt that BZM will not be attending any i/v at JIRT and will seek legal advice regarding her responsibility and involvement with the JIRT matter.

- i/v appointment for this afternoon at 4:00pm cancelled by BZN.

- BZN stated that they are happy for BZM's written statement to be used in Court, with no av JIRT interview.

P/c to BZN

- BZN stated that the above, and added that they have received legal advice from a Criminal Lawyer that BZM do not have to attend Court if she does not want to, even if subpoenaed. CW offered to enquire for her if this is the case, and BZN refused stating that they have got the advice already and have made their decision.

- CW spoke to BZN about counselling and explained the importance and process a CSA counselling service entail. BZN refused this service both for BZM and herself and believes that by not dwelling on it i.e. JIRT involvement and counselling, that BZM would be much happier.

- BZN stated that if they change their mind they will contact CW for CSA referral.

- CW informed BZN that JIRT Police will go ahead with their investigation and may contact victims in the process. BZN requested that they are not contacted by Police, as she would like BZM to 'forget about this issue'.
