- BZN stated that she cancelled the appointment due to difficulties in getting to JIRT.

- BZN stated that she has 3 'extremely busy' children whom she has to run around for, and she works full time.

- BZN stated that she has been reluctant for BZM to be interviewed as BZM has been very busy with the up coming dance performance which is on next Friday.

- BZN stated that BZM moods and behaviour had changed when she was anticipating speaking with Burwood Police and is now also extremely anxious and scared about being interviewed on camera.

- BZN stated that she wanted BZM to concentrate on her dance performance, without having any other distraction.

Snr/con Jason Madson had contacted BZM and left a message for her to contact JIRT.

- BZM stated that her phone was out of battery the other night.

- BZM is reluctant to be interviewed for the following reasons:

* BZM is good friends with BZL and BZL has told her that she is not going to speak to Police or JIRT. BZM is now resentful that she has to be interviewed and BZL isn't.

* BZM is scared about being video taped during the interview and is not sure of the procedure during the interview and after.

* BZM brother is still attending RG Dance school, and BZM still sees Grant from time to time.

- discussed with BZM the importance of BZM interview at JIRT and explained that Jason would discuss with her how her evidence will be used.

- Also discussed with BZM about BZM recent behaviour and the possible need for counselling.

- BZM is happy for BZM to be interviewed but due to BZM training 5 days a week, i/v will need to be after hours. Suggested the following:

* Early morning i/v - Officers can collect BZM and return her to school. BZM stated that BZM wants her to be with her when she attends JIRT. However BZM will need to leave her 9 and 11 yo boys at home unattended. BZM stated that she has no family or friends that can come and care for the boys in the morning.

* during school hours - BZM stated that she works full time and cannot take time off as she only gets paid on days that she works, and due to finance this is not an option.

- Booked i/v for Tuesday 20/03/07 @ 7/7:30pm. According to BZM after hours is more convenient for BZM as getting her out of bed at early hours would be draining for her throughout the day. BZM stated that BZM attends MacDonalds Performing Arts and is studying to attend a prestigious dance school in London, so for BZM dancing is her life. BZM stated that to make BZM miss a lesson or school, would stress BZM more, and is likely to 'dig her heels in' and refuse to speak to JIRT.

BZM suggested for CW to call BZM on her mobile: REDACTED as this may alleviate some of BZM anxiety about being interviewed at JIRT. BZM also suggested for a female officer to i/v BZM as BZM is extremely anxious about speaking to a male officer.
