	<p>The following report was Que Managed by CPCW Adeline Ahiau and Inital Assessment was created bu CPCW Kathryn Stables</p> <p>Brief details of issues:</p> <p>Caller advised that on Thursday 08/02/2007, the family approached the Directors of RGDANCE School having discovered that one of the directors had been having inappropriate sexual communications with there child, caller believes that the parents had come across some information on the computer in which the director had typed an explicit dream he had about the child and had sent it to her, following on from this, n/p's confronted the child and acknowledged that it had happened, and caller believes that there also has been contact by text messaging. Caller advised that the family came into meet the directors on 08/02/2007 and Director Grant DAVIES (POI) acknowledged in the presence of his co-director Rebbecca DAVIES (sister of POI), that what was alleged he had done and apologised to the family, apparently he broke down and wept.</p> <p>Caller believes that at the meeting the family requested that the POI was to seek treatment for his behaviour and stop teaching for a reasonable period of time. Caller advised that the Director stopped teaching for a week and has resumed teaching on 17/02/2007. Caller advised that since then there have been suggestions that the POI's behaviour has been occurring with other students however the parents of the other students do not want to take matters further. Caller advised that the POI is receiving counselling and apparently it was recommended by the Counsellor that he return back to work to maintain a normal life.</p> <p>Caller advised that on 20/02/2007, Directors called a meeting with all parents involved in the school, at the meeting they did not disclose the details of what had taken place with the child and the line that they used was that the rumours that were circulating around the school weren untrue.</p> <p>continue Q8</p>

	<p>Caller advised that [redacted] is not in a position to determine whether the POI is continuing his behaviour with other children and there has not been any disclosures made by any other children.</p> <p>Caller advised that the child is not returning back to the Dance School and is no longer at any risk by the POI.</p> <p>The school consists of 250 students, 80% female aged from 3 – 17 years old. Caller advised that [redacted] has received this information from having conversations with the family and with the Directors as [redacted] Section 29 [redacted] caller advised that during this time the POI has admitted to [redacted] what [redacted] has reported.</p>
