JIRT have confirmed the sexual abuse of BZP and others however the Police are yet to charge as they want to gain more information and press more charges.</i></p> <p><i>As POI is not formally charged Burwood CSC is not able to inform other parents of the potential risk to their children due to privacy laws.</i></p>

	<p><i>This matter is currently being investigated by Police. Police have advised that caseworker's interviewing the POI may interfere with current investigation. As POI owns studie and has not being formally charged with child sex offences there is little that can be done by CSC. If he is charged by Police it is up to them to inform parents of children he has access to that he is on the Child Protection Register. If it is believed that children are still at risk from him then the Police will make reports as mandated reporters.</i></p> <p><i>It is obviously very concerning that this person still has access to children on a daily basis. However, Burwood CSC is unable to take further action until Police formally charge him and he is convicted. JIRT have substantiated the sexual abuse of BZP [redacted] and therefore it is clear that Grant Davies does pose a risk to the children he comes into contact with.</i></p>
