Caller had **Section 29** a dance school RG Dance -- Address: 15-17 Bibby St Chiswick that **Section 29** has concerns about. The school is run by a brother and sister -names are: Grant and Rebecca Davis. **Section 29** **Section 29** concerns relating to the inappropriate behaviour of Grant. Grant is in his 30's. Due to Grant's behaviour many of the parents have taken their children out of the school.

The caller has been told that the school, especially Grant, were being investigated by DoCS or the police (possibly both) and because **Section 29** was not sure if this is true the caller wanted to add **Section 29** observations **Section 29** **Section 29**

The caller stated that **Section 29** observed Grant being very flirtatious with the teenage girls attending the school. He would encourage the girls to be very flirtatious back. He was over the top complimentary towards his favourite students and the compliments were usually related to their physical appearance. For instance on one occasion he pointed out one of the girls to the caller saying isn't she beautiful? Isn't she stunning? Look at her legs are they not gorgeous, she has a great body and this child was 12yrs old. He often used this type of language towards the children.

He often told 7&8 yr olds girls to sex it up whilst they were dancing that the caller thinks is inappropriate.

The caller states that since a lot of the early teenage girls have been taken out of the school he has now moved onto the younger ones (7 and 8yr olds).

According to the caller Grant became obsessed and fixated on particular students. These girls were usually pretty and talented and pre pubescent (around 12yrs). Grant was either very complimentary or very verbally or emotionally abusive towards the girls. He would bully the student into performing better.

The caller observing him encouraging the girls to flirt with him and would on occasion place his face close to the girls' crutch when they were stretching.

The caller heard that on a recent flight to Las Vegas with girls from his school in the last school holiday he was encouraging girls to sit on his lap. This apparently made lots of people on the plane uncomfortable so much so that some made complaints to the stewardess.

The caller believes there were strong concerns last year when Grant exchanged text messages with some of the girls about fantasies and dreams apparently about having threesomes and believes that is why he was investigated and why some of the students have been taken out of the school.

There have been 4 previous report regarding inappropriate behaviour of Grant DAVIS at the school, dating from Feb 2007.

Last record Judgements and Decisions 17/07/2007 states that ROH is likely and there is a High level of risk - Criminal Action will be taken re: sexual: indecent acts/molest.

Previous records indicate that Grant will be charged with aggravated indecent assault after a student made a statement that Grant had put his hand down her top on to her breasts and moved them, he said he was adjusting them for performance purposes. There have also been reports of inappropriate internet MSN conversations and questions, and sending explicit emails and text messages.

Records for PN 1-A3CBQB indicate there is an ongoing police/JIRT investigation, records 10/08/2007 indicate Grant has not been arrested or made aware of all the allegations, as the investigation still in evidence gathering stage, police have confiscated Grant's computer and mobile phone for evidence.
