| <p>Section 29 has reported to Section 29 that on 09.04.2013 Section 29 has found sexually explicit conversations on Section 29 Grant Davis's computer that were between Mr Davis, BZD and her mother, Ms. BZC</p> <p>Section 29 presented Section 29 with over 50 pages of this conversation.</p> <p>BZC and BZD share the same internet account named "BZC BZD mum".</p> <p>The reporter indicates that even though the account was shared between BZD and BZC it is clear when Mr. Davis is talking to BZD through the messages it appears that BZC is encouraging sexual activities between BZD and Mr. Davis.</p> <p>The most concerning messages include Mr. Davis stating "I need some soft skin against my hard cock" with the emphasis that he wanted to this to BZD. The reporter indicates that it is clear that this statement was directed at BZD as he asked where she was and if she was home.</p> <p>BZC also sent a photo to Mr. Davis of BZD in a G-String posing in a sexual way.</p> <p>Section 29 has provided Section 29 with BZC's phone number and also a piece of paper with an address on it which Section 29 believes is BZC's. However, Section 29 have not confirmed this.</p> <p>Section 29 looking at charging Mr. Davis with grooming offences however he will not be informed of the allegation until further evidence is gathered. Section 29 will be tracing the IP and telephone service provider to locate BZD and BZC</p> | | | | | |

Any important information about current circumstances that need to be highlighted?</p> | <p>Mother of ^{BZD} Ms. ^{BZC}</p> <p>^{BZB} and ^{CAH} are residing with the paternal aunt Ms. Rebecca Davis at ^{REDACTED} ^{BZB} has indicated that she will not be allowing any further contact between Mr. Davis and ^{CAH}</p> <p>^{BZD} is currently in the care of ^{BZC}. Their current location is unknown however police believe they reside in South Australia and are following up.</p> | | |
| <p>Previous involvement with the family: Any Community Services history with child or family. Brief outline</p> | <p>There is no child protection history for ^{BZD}.</p> <p>^{CAH} has 2 reports since 19/12/2006.</p> <p>Report dated 08/08/2007 indicate that ^{CAH} is at risk of sexual harm due to having contact with her father, Mr Grant Davis. Mr. Davis has been identified as the person causing harm to ^{BZP}</p> <p>Mr. Davis and his sister Ms. Rebecca Davis were directors of a dance studio. Parramatta JIRT investigation indicate that Mr. Davis had</p> <ul style="list-style-type: none"> - grabbed the child's breast, and moved them about whilst supposedly adjusting her bra during a dance competition - Make the children bend down with their bottom's sticking up supposedly to check that the children's leotards were on correctly - making sexual comments to girls at the dance school, and conversing with them on the internet about sexual matters - masturbating whilst he is talking to a child on the internet <p>Parramatta JIRT indicate that there was a clear grooming process of Mr. Davis victims i.e. befriending the child, making her feel special, gradual escalation of 'touching' and threats of not being given roles in dance productions and being made to work harder in class, if child distances herself from Mr Davis' advances.</p> <p>Secondary assessment indicates that police have advised Community Services Caseworkers that interviewing Mr. Davis may interfere with their current investigation. Mr. Davis has not been formally charged with child sex offences and there is little that can be done by Community Services. Community Services note concerns that Mr. Davis has daily contact with children however Community Services are unable to act until Mr. Davis is charged. It further notes that it is up to the Police to inform the parents of the children that he has access to that he is on the Child Protection Register.</p> | | |
