Narrative

CIB is intellectually handicaped, she apparently is functioning on a 3-5 yr old level. A few months ago the mother made the decision to place CIB at a school where is could develop independent living skills and chose Mater Dei as the school.

CIB has been residing in a cottage that was shared with 3 male residents and had a male house parent by the name of CID. No other female present in the cottage.

CIB was returning to her mothers care each weekend and during the holiday periods. The weekend of 25-26 May, CIB and her mother were visiting the mountains, apparently CIB went to the toilet, and when she returned to her mother complained about looseing blood. She was taken to the casulty section of Nepean Hospital, were she was admitted, she under test with scopes on the Monday by DrCredan. He noticed an ulcer in the bowel. No reason given at that time of how the ulcer may have resulted. Child is on heavy doses of a variety of medication for epilepsy.

No reason has been given of how the ulcer may have developed. I received a phone call from the senior social worker at Nepean Hosp, Judith Case on Friday 31.5.91, no making a notification but wanting to know if any thing could be done to have the female / male ratio with the cottage changed. No specific allegations of sexual abuse were made, general concerns were discussed, CIB had raised a couple of her concerns with Judith who relayed them to me. These concerns were apparently raised with the Princilpe of Mater Dei School by CIB a number of weeks before who reassured her they check the cottages regulary to ensure nothing was going on that shouldn't.

CIB concerns were:

1. CIB had told her that CID was lying down and was sick. When this was explored further with CIB by her mother, mother thinks he must have been drinking.
2. CID had stated on day when mother was picking up her daughter that he had caught "REDACTED" coming out of the bath room, where she had been with a boy.

Phone call today from natural mother, who was quite upset, she had been given my name and p/number by Ms Case, regarding her daughter. The child had remained in hospital untill Wed,29.5.91, and CIB kept her home untill Sunday, 2.6.91, when she returned child to Mater Dei, she went to her own Dr, Dr Gilroy, on Monday night, who told mother the only way the ulcer could result was by sexual abuse. Dr Gilroy apparently rany Dr Cregan the surgen, who said there was trauma, this may be the result of abuse but could also be the result of the operation with the scope.

CIB now firmly believes her daughter has been sexually assulted. Child removed by mother from school on the Monday night. Child taken to Dr, Gilroys on Tuesday and questioned by Dr. Gilroy. Mother stated Dr asked "who made you bleed". Child stated "REDACTED hurt hard" she also said "he hurt me with scissors", mother stated at the time when child said this she was actually playing with scissors, and will frequently associate what she is doing curraently with the past - this doesnt mean it happened.

Mother has spoken to school, and her own solicitor, school have apparently spoken to police and a solilcitor and CID has been requested to terminate his employment, this occured on Wed 5.6

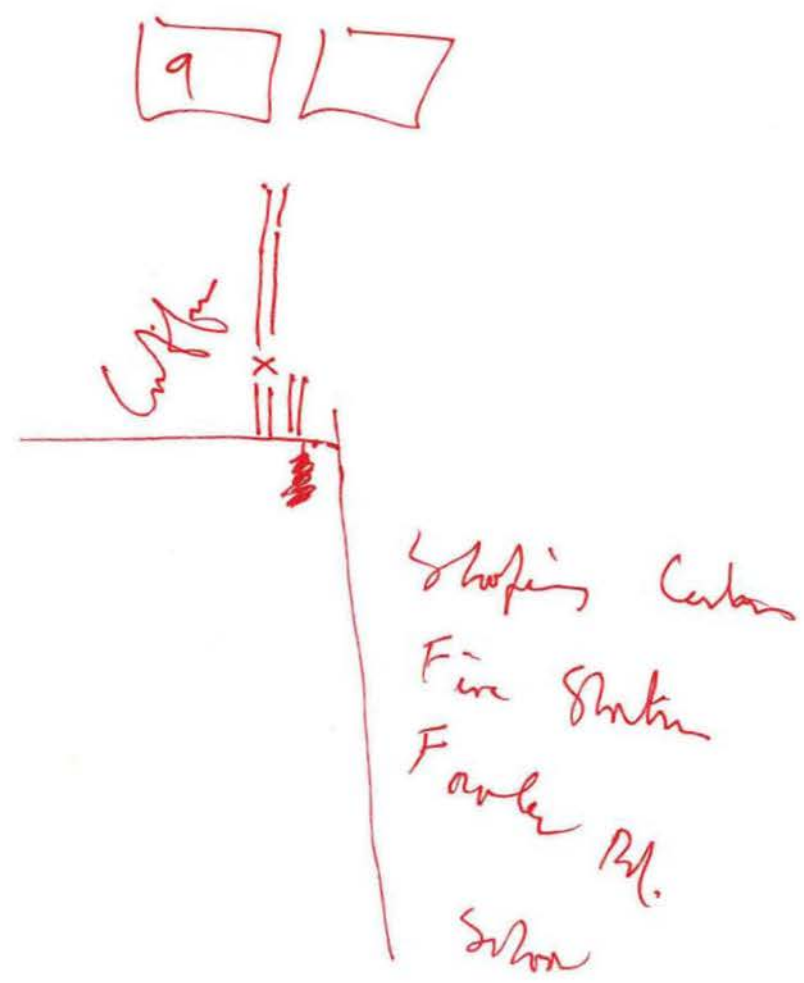
