CIL has been at Mater Dei since 1987. During this time he resided at a cottage in REDACTED, Camden until he was moved at the beginning of 1990. The following information was obtained by the recently appointed principal Sue Dixon. It has been reported that the male social educator was observed to behave towards CIL in an inappropriate manner such as ; a worker observed that CIL bed was made very early one morning and CIL replied that he had not slept in his bed but had slept in CID bed (male social educator). On another occasion CID was observed to carry CIL to the bath room and place him in the bath, wash him, than wrap him in a towel and carry him to his bedroom where he dried, CIL and played "tickels" before CIL was clothed. CIL was twelve years old at this time.
