19	ROSH, Harm Or Neglect Issues: On 20/03/2012 CIE spent a few hours with respite worker Royce UNKNOWN (through Interchange Respite Care Service). When CIE returned from respite CIE disclosed he was sexually assaulted by respite worker Royce. Royce took CIE riding bicycles in the community.  When CIE returned from respite CIE appeared stressed and anxious.  CIE has diagnosed autism and is non-verbal (uses QWERTY key board to communicate).  CIE said to the REDACTED (using the QWERTY keyboard) "I want you to come with me next time" REDACTED asked why CIE said "Royce touched my willy he has got form because he has done this before" REDACTED asked when CIE said "I met Royce at Disability Trust at afterschool care and he did it there as well" REDACTED asked how many times CIE said "lots of time" REDACTED asked "why didn't you tell me about it" CIE said "I thought it was my fault because I got aroused but I didn't want him to do it"  Contactor stated that CIE is high functioning physically, doesn't need self care help in the bathroom.  REDACTED has reported matter to the police. CIE has provided written statement to police.  REDACTED has advised Interchange Respite Care Provider Shoal Haven that she no longer wants worker Royce (unknown if the REDACTED has advised the service about the allegation). REDACTED very protective, no further contact between CIE and POI.  The REDACTED hasn't advised respite worker Royce's other work places.  On 22/03/2012 ADHC psychologist will complete home visit to support CIE given his emotional state.  AOD: No MH: CIE has behavioural issues related to autism diagnosis, challenging behaviours, violence, obsession with water, no previous sexualised behaviours.  NOTE: REDACTED a month ago and met POI Royce who was subsequently employed at Focus (Disability Support Service). Royce works for the three disability support agencies and had no previous known allegations of offences against children.	Details in comments

	<i>CLASS of children who receive care from The Disability Trust Nowra are at risk of sexual harm given a client CIE (Aged 15) disclosed a staff member Royce UNKNOWN (Aged 20's) touched his penis multiple occasions and he didn't like it.</i>	
	<i>The class children vulnerable given service for children with disabilities. It is unknown when Royce is working with children next, access unknown.</i>	
	<i>The likelihood of harm continuing is moderate given the current victim CIE said the inappropriate touching has happened multiple occasions over period of time. There was no child protection history located for staff member Royce UNKNOWN given lack identifying information.</i>	
	<i>A separate report for victim CIE has been transferred to Joint Investigation Response Team. POI Royce UNKNOWN works for three disability service workplaces including: Interchange; The Disability Trust and Focas Disability Services, all services based in Nowra. Separate reports have been completed for the CLASS of children at each service. Allegation against staff working with children has been completed.</i>
