REDACTED /49 of REDACTED who states that his two sons, REDACTED /73 and REDACTED

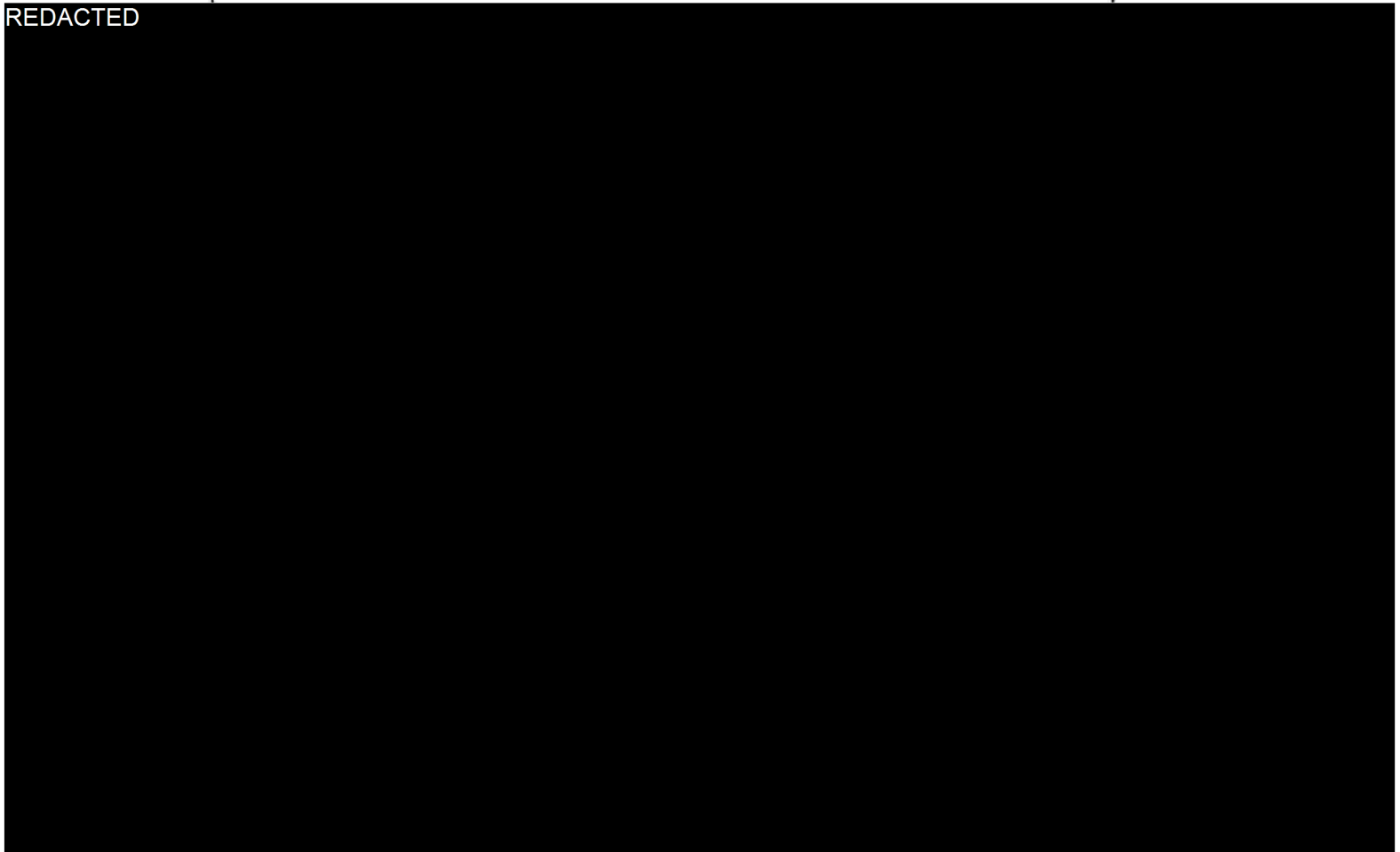

REDACTED attended the Station with his sons at 1530Hrs this date and statements obtained. Both boys allege that whilst in the pool they were approached by a male person between 35-40 years of age with brown to greying hair, muscular arms and hairy chest wearing red trunks. He then proceeded to grab REDACTED and place him on his lap and then started rubbing up against his buttocks with his erect penis. He later grabbed REDACTED and repeated the process. At that time of the morning there were very few people present and JEFFS has given the names of two possible suspects namely a REDACTED an Insurance Rep and a person by the name of REDAC. Both persons were wearing red bathers at the time. REDACT could possibly be REDACTED of REDACTED 52. REDACTED could possibly be a REDACTED Evening Shift to check possible whereabouts and vehicles of both persons. Day shift Det's MURPHY/CASEY to attend pool at 0700Hrs to check for suspects.
