

IN THE SUPREME COURT OF THE
NORTHERN TERRITORY OF AUSTRALIA

The Director of Public Prosecutions for the Northern Territory of Australia, charges that

GREGORY ROBERT KNIGHT

Count 1

Between 1 January 1991 and 31 December 1991 at Darwin in the Northern Territory of Australia, unlawfully assaulted **REDACTED**
REDACTED

AND THAT the said assault involved the following circumstances of aggravation:-

- (i) that **REDACTED** was under the age of 16 years and Gregory Robert Knight was an adult;
- (ii) that **REDACTED** was indecently assaulted.

Section 188(1), (2)(c) and (k) of the Criminal Code.

Count 2

Between 1 June 1993 and 30 June 1993 at Darwin in the Northern Territory of Australia, unlawfully assaulted **REDACTED**
REDACTED with intent to commit an act of gross indecency on him.

AND THAT the said assault involved the following circumstances of aggravation:-

- (i) that **REDACTED** was under the age of 16 years and Gregory Robert Knight was an adult;

- (ii) that Gregory Robert Knight thereby committed an act of gross indecency on REDACTED

Section 192(1), (2) and (3) of the Criminal Code.

Count 3

Between 1 July 1993 and 30 August 1993 at Darwin in the Northern Territory of Australia, unlawfully committed an act of gross indecency in private with a male, namely REDACTED REDACTED who is not an adult.

Section 128(1)(b) of the Criminal Code.

Count 4

On 14 October 1993 at Darwin in the Northern Territory of Australia, unlawfully committed an act of gross indecency in public with a male, namely REDACTED

AND THAT the said act of gross indecency involved the following circumstances of aggravation:-

- (i) that REDACTED was under the age of 14 years and Gregory Robert Knight was an adult;

Section 127(1)(b) and (2) of the Criminal Code.

Count 5

On or about 14 October 1993 at Darwin in the Northern Territory of Australia, unlawfully assaulted REDACTED with intent to commit an act of gross indecency on him,

AND THAT the said assault involved the following circumstances of aggravation:-

- (i) that REDACTED was under the age of 16 years and Gregory Robert Knight was an adult;

(ii) that Gregory Robert Knight thereby committed an act of gross indecency on REDACTED

Section 192(1), (2) and (3) of the Criminal Code.

Count 6

On 14 October 1993 at Darwin in the Northern Territory of Australia, unlawfully committed an act of gross indecency in public with a male, namely REDACTED

Section 127(1)(b) of the Criminal Code.

Count 7

On 15 October 1993 at Darwin in the Northern Territory of Australia, unlawfully committed an act of gross indecency in public with a male, namely REDACTED

Section 127(1)(b) of the Criminal Code.

Count 8

On 14 October 1993 at Darwin in the Northern Territory of Australia, unlawfully committed an act of gross indecency in public with a male, namely REDACTED

Section 127(1)(b) of the Criminal Code.

Count 9

On or about 14 October 1993 at Darwin in the Northern Territory of Australia, unlawfully committed an act of gross indecency in private with a male, namely REDACTED who is not an adult.

Section 128(1)(b) of the Criminal Code.

Count 10

On or about 14 October 1993 at Darwin in the Northern Territory of Australia, unlawfully committed an act of gross indecency in public with a male, namely REDACTED

Section 127(1)(b) of the Criminal Code.

Count 11

Between 1 April 1992 and 31 August 1992 at Darwin in the Northern Territory of Australia, unlawfully assaulted REDACTED REDACTED with intent to commit an act of gross indecency on him,

AND THAT the said assault involved the following circumstances of aggravation:-

- (i) That REDACTED was under the age of 16 years and Gregory Robert Knight was an adult;
- (ii) That Gregory Robert Knight thereby committed an act of gross indecency on REDACTED.

Section 192(1), (2) and (3) the Criminal Code.

Count 12

Between 1 July 1992 and 31 December 1992 at Darwin in the Northern Territory of Australia, unlawfully committed an act of gross indecency in private with a male, namely REDACTED REDACTED who is not an adult.

Section 128(1)(b) of the Criminal Code.

Count 13

Between 1 July 1992 and 31 October 1992 at Darwin in the Northern Territory of Australia, had carnal knowledge in

private of a male, namely REDACTED who is not an adult.

Section 128(1)(a) of the Criminal Code.

Count 14

Between 1 January 1993 and 30 June 1993 at Darwin in the Northern Territory of Australia, unlawfully committed an act of gross indecency in private with a male, namely REDACTED REDACTED who is not an adult.

Section 128(1)(b) of the Criminal Code.

Count 15

Between 1 May 1993 and 30 June 1993 at Darwin in the Northern Territory of Australia, unlawfully had carnal knowledge in private of a male, namely REDACTED who is not an adult.

Section 128(1)(a) of the Criminal Code.
