Summary

Meeting with John Weekes from Knox Grammar and Grahame Wilson of the AIS.

John provided further information in relation to Adrian Nesbitt (C/2003/8367). John advised that the victim in this matter, ASA [redacted] aka ASA [redacted] had at the time refused to be interviewed in relation to allegations that Mr Nesbitt had supplied him with cigarettes and alcohol and given him a huc ASA [redacted] has come to see John in January 2007 and disclosed further details in relation to the alleged assault ASA [redacted] has advised that in 2002 Mr Nesbitt provided him with cigarettes and alcohol and put his hand down ASA [redacted] pants before performing oral sex on him ASA [redacted] advised John that he does not wish to pursue this matter further at this time and he does not want anyone to know about what has occurred.

John advised that he believes Adrian Nesbitt is currently working as a photographer, taking photos of animals in Africa and travels regularly between Africa and Australia. It was suggested that the school

contacts the police to discuss the issues and possibly report matter as 'intelligence', withholding the names of the victims, as per their wishes. File note in relation to this meeting is attached to C/2003/8367
