PARTICULARS

AND STATEMENT OF OFFENCE

**CHARGE 1** The Director of Public Prosecutions charges that DAVID WILLIAM OSBORNE at The Basin in Victoria between the 19<sup>th</sup> day of December 1969 and the 25<sup>th</sup> day of May 1970 unlawfully and indecently assaulted STEVEN DAVID GRANT a male person.

**Statement of Offence** –Indecent assault on a male person contrary to s.68(3A) of the Crimes Act 1958.

**CHARGE 2** The Director of Public Prosecutions charges that DAVID WILLIAM OSBORNE at The Basin in Victoria between the 19<sup>th</sup> day of December 1969 and the 25<sup>th</sup> day of May 1970 on an occasion other than that referred to in charge 1 unlawfully and indecently assaulted STEVEN DAVID GRANT a male person.

**Statement of Offence** –Indecent assault on a male person contrary to s.68(3A) of the Crimes Act 1958.

**CHARGE 3** The Director of Public Prosecutions charges that DAVID WILLIAM OSBORNE at The Basin in Victoria between the 19<sup>th</sup> day of December 1969 and the 25<sup>th</sup> day of May 1970 on an occasion other than that referred to in charges 1 and 2 unlawfully and indecently assaulted STEVEN DAVID GRANT a male person.

**Statement of Offence** –Indecent assault on a male person contrary to s.68(3A) of the Crimes Act 1958.

**CHARGE 4** The Director of Public Prosecutions charges that DAVID WILLIAM OSBORNE at The Basin in Victoria between the 19<sup>th</sup> day of December 1969 and the 25<sup>th</sup> day of May 1970 on an occasion other than that referred to in charges 1, 2 and 3 unlawfully and indecently assaulted STEVEN DAVID GRANT a male person.

**Statement of Offence** –Indecent assault on a male person contrary to s.68(3A) of the Crimes Act 1958.

**CHARGE 5** The Director of Public Prosecutions charges that DAVID WILLIAM OSBORNE at The Basin in Victoria between the 19<sup>th</sup> day of December 1969 and the 25<sup>th</sup> day of May 1970 assaulted STEVEN DAVID GRANT.

**Statement of Offence** –Common Assault contrary to Common Law.
