1. My full name is CDT I am 61 years of age. My date of birth is REDACTED 1949.
2. I have previously made a statement to police regarding the sexual and physical abuse that I suffered when I was 16 years of age and undergoing a sentence at the Bayswater Youth Training Centre.
3. I have been asked to provide a further statement in regards to this matter by the police informant.
4. I have been asked to provide further particulars about the sexual offences that were committed by Boss Poulter on myself.
5. I did not elaborate on these offences in great detail during the taking of my original statement. The original statement was taken by a female police officer. I was embarrassed to talk about what had happened to me. I gave my answers in response to the questions that I was asked by the Police lady who was taking the statement.
6. CDT I know MIAAS happened to me. I recall clearly Boss Poulter sexually assaulting me.
7. I know that it was Boss Poulter that sexually assaulted me. Boss Poulter was the third adult who was in authority that I met at Bayswater Youth Training Centre.
8. Each employee at the Youth Training Centre had a name. They referred to themselves by their surname. Boss Poulter told me his name. Over the period of time that I was at the Bayswater Youth Training Centre I heard other boys call him Boss Poulter.
9. At paragraph 16 in my original statement I stated that Boss Poulter would make me masturbate his penis and that he would do the same to me.
10. I had arrived at the Bayswater Youth Training Centre on the 9<sup>th</sup> of September, 1965. I was in trouble for the first three days. Boss Poulter had introduced himself to me in a solitary punishment room on about the third day since I had arrived.
11. On about the fourth day I was allowed to sleep in my own room.
12. For the first two or three nights Boss Poulter came into my room at night and just spoke to me. He kept emphasising to me that if I behaved that I wouldn't have to go back to the solitary room, and that he would protect me from the other officers if I did behave.
13. On about the fourth night I was in my own room Poulter started to put his arm around me and told me that I should appreciate what he was doing for me. He cuddled me and rubbed my leg.

14. It was dark outside. It was after everybody had gone to bed and they were all in their rooms. I was in bed when he came into my room. I can't recall how the room was lit but it was light in the room when he was in my room.
15. At this time he was sitting on my bed with me. I was also on my bed.
16. This was the first time that he sexually assaulted me.
17. Poulter has tried the soft approach with me but it didn't work. He had put his arms around me, cuddling. He rubbed my thigh. He took hold of my hand and tried to get me to touch his penis.
18. I did not respond to his touching. I tried to say no to his touching. Poulter got agitated and became angry towards me.
19. He threatened to put me back in the solitary room if I didn't cooperate.
20. He then grabbed me by the wrist and held my hand to his penis. I was frightened of him. He had his pants on and forced my hand onto his penis on the outside of his pants.
21. He took his penis out of his pants. His penis was erect and he forced my hand to touch his penis. He had hold of my hand by the wrist.
22. At first I wouldn't touch his penis. He then made me take my penis out of my pants and started to masturbate my penis. He was showing me how to masturbate his penis. He masturbated my penis. My penis was erect.
23. He kept threatening me. So I eventually gave in thinking that if I did it he would leave me alone. I masturbated his penis. I did this until he ejaculated. I think he might have had a handkerchief that he ejaculated into.
24. After the finished he told me I was a good boy, and that it was easy to do. He told me that I didn't have to worry about the solitary room or the other officers.
25. At paragraph 18 in my original statement I have stated that Boss Poulter forced me to perform oral sex on him.
26. This occurred about two days after Boss Poulter had forced me to masturbate him.
27. The first time that I was forced to perform oral sex on Boss Poulter I was in my room. It was at night. Everyone was in their own rooms. Boss Poulter came into my room.
28. He sat next to me on my bed. He started by getting me to masturbate his penis. I resisted him, but he threatened me to share me with the other officers. He told me that he was not the only one that does this, referring to sex.

29. I masturbated his penis with my hand. Then he told me to suck his penis. I wouldn't do it. He stood in front of me. I was on my bed. His penis was exposed and erect. He grabbed me by my ears and tried to forced me to suck his penis.
30. He stuck his nails into my ears to cause me pain. I eventually opened my mouth and he put his erect penis into my mouth.
31. I wouldn't suck his penis so he thrust his penis in and out of my mouth until he ejaculated in my mouth. I was crying all the time.
32. I was trying not to cry out loud I didn't want anyone else knowing what was going on.
33. After he ejaculated in my mouth I swallowed it.
34. At paragraph 19 in my original statement I have stated that Boss Poulter raped me by forcing his penis into my anus.
35. The first time that this happened was either the first or second night after Boss Poulter had forced me to perfume oral sex on him.
36. He came into my room that night. It was after dark and everyone had already gone to their rooms.
37. I was on my bed. Boss Poulter told me that he was going to try to get me to like having sex with a man. He said that he was going to screw me. I knew what he meant.
38. I was upset and crying. He said that if I don't let him do it, he would have to get someone else to hold and that there would be two of them doing it.
39. I gave in. He told me to kneel on my bed on my hands and knees with my head facing the wall. He stood behind me. He forced his penis into my anus. It hurt. It felt like doing a huge crap but in reverse, something going in instead of coming out.
40. I cried out to him that it was hurting. He said that it wont hurt after a while.
41. He thrust his penis in and out of my anus. He grunted at the end and stopped.
42. After he finished he said something like, "It wasn't that bad after all"
43. I had the fear of others finding out what had happened, or that he would get others to do it to me also.
