**PARTICULARS**  
**AND STATEMENT OF OFFENCE**

**CHARGE 1** The Director of Public Prosecutions charges that **DAVID EDWIN RAPSON** at Lysterfield in Victoria between the 1<sup>st</sup> day of January 1975 and the 30<sup>th</sup> day of December 1976 unlawfully and indecently assaulted a male namely <sup>CGF</sup>   <sub>CGF</sub>.

**Statement of Offence** – Indecent assault on male contrary to s.68 (3A) of the *Crimes Act* 1958.

**CHARGE 2** The Director of Public Prosecutions charges that **DAVID EDWIN RAPSON** at Sunbury in Victoria between the 1<sup>st</sup> day of January 1975 and the 1<sup>st</sup> day of June 1975 unlawfully and indecently assaulted a male person namely <sup>CGH</sup>   <sub>CGH</sub>.

**Statement of Offence** – Indecent assault on male contrary to s.68 (3A) of the *Crimes Act* 1958.

**CHARGE 3** The Director of Public Prosecutions charges that **DAVID EDWIN RAPSON** at Sunbury in Victoria between the 1<sup>st</sup> day of January 1977 and the 31<sup>st</sup> day of December 1977 unlawfully and indecently assaulted a male person namely <sup>CGI</sup>   <sub>CGI</sub>.

**Statement of Offence** – Indecent assault on male contrary to s.68 (3A) of the *Crimes Act* 1958.

**CHARGE 4** The Director of Public Prosecutions charges that **DAVID EDWIN RAPSON** at Sunbury in Victoria between the 1<sup>st</sup> day of January 1977 and the 31<sup>st</sup> day of December 1977 on an occasion other than that referred to in charge 3 unlawfully and indecently assaulted a male person namely <sup>CGI</sup>   <sub>CGI</sub>.

**Statement of Offence** – Indecent assault on male contrary to s.68 (3A) of the *Crimes Act* 1958.

**CHARGE 5** The Director of Public Prosecutions charges that **DAVID EDWIN RAPSON** at Sunbury in Victoria between the 1<sup>st</sup> day of January 1987 and the 31<sup>st</sup> day of December 1987 indecently assaulted <sup>CGJ</sup> [REDACTED].

**Statement of Offence** –Indecent Assault contrary to s.44 (1) of the *Crimes Act* 1958.

**CHARGE 6** The Director of Public Prosecutions charges that **DAVID EDWIN RAPSON** at Sunbury in Victoria between the 1<sup>st</sup> day of January 1988 and the 31<sup>st</sup> day of December 1988 indecently assaulted JAMES BRANDT.

**Statement of Offence** –Indecent Assault contrary to s.44 (1) of the *Crimes Act* 1958.

**CHARGE 7** The Director of Public Prosecutions charges that **DAVID EDWIN RAPSON** at Sunbury in Victoria between the 1<sup>st</sup> day of January 1988 and the 17<sup>th</sup> of May 1988 raped <sup>CGK</sup> [REDACTED] by introducing his penis into the anus of <sup>CGK</sup> [REDACTED] <sup>CGK</sup> [REDACTED] without his consent.

**Statement of Offence** -Rape contrary to s.45 (1) of the *Crimes Act* 1958.

**CHARGE 8** The Director of Public Prosecutions charges that **DAVID EDWIN RAPSON** at Sunbury in Victoria between the 1<sup>st</sup> day of January 1989 and the 31<sup>st</sup> day of January 1990 indecently assaulted <sup>CGL</sup> [REDACTED].

**Statement of Offence** –Indecent Assault contrary to s.44 (1) of the *Crimes Act* 1958.

**CHARGE 9** The Director of Public Prosecutions charges that **DAVID EDWIN RAPSON** at Sunbury in Victoria between the 1<sup>st</sup> day of March 1990 and the 13th day of April 1990 raped <sup>CGM</sup> [REDACTED] by introducing his penis into the anus of <sup>CGM</sup> [REDACTED] without his consent.

**Statement of Offence** –Rape contrary to s.45 (1) of the *Crimes Act* 1958.

**CHARGE 10** The Director of Public Prosecutions charges that **DAVID EDWIN RAPSON** at Sunbury in Victoria between the 30<sup>th</sup> day of April 1990 and the 31st day of May 1990 raped <sup>CGM</sup> [REDACTED] by introducing his penis into the anus of <sup>CGM</sup> [REDACTED] without his consent.

**Statement of Offence** –Rape contrary to s.45 (1) of the *Crimes Act* 1958.

**CHARGE 11** The Director of Public Prosecutions charges that **DAVID EDWIN RAPSON** at Sunbury in Victoria between the 30<sup>th</sup> day of April 1990 and the 31<sup>st</sup> day of May 1990 on an occasion other than that referred to in charge 10, raped   by introducing his penis into the anus of  without his consent.

**Statement of Offence** –Rape contrary to s.45 (1) of the *Crimes Act* 1958.

**CHARGE 12** The Director of Public Prosecutions charges that **DAVID EDWIN RAPSON** at Sunbury in Victoria between the 1<sup>st</sup> day of July 1990 and the 31<sup>st</sup> day of August 1990 raped   by introducing his penis into the anus of  without his consent.

**Statement of Offence** –Rape contrary to s.45 (1) of the *Crimes Act* 1958.

**CHARGE 13** The Director of Public Prosecutions charges that **DAVID EDWIN RAPSON** at Sunbury in Victoria between the 1<sup>st</sup> day of July 1990 and 31<sup>st</sup> day of August 1990 indecently assaulted .

**Statement of Offence** –Indecent Assault contrary to s.44 (1) of the *Crimes Act* 1958.
