That on a date unknown between the sixteenth day of April, 1952 and the seventeenth day of April, 1956 near Rockhampton in the State of Queensland **REGINALD BASIL DURHAM** unlawfully and indecently dealt with **ALLAND WILLIAM ALLAWAY** a boy under the age of 17 years

And further that at the time aforesaid the said **ALLAN WILLIAM ALLAWAY** was under the age of 14 years

AND WHEREAS there is reasonable cause to believe that the said **REGINALD BASIL DURHAM** is mentally ill or was mentally ill
