That on a date unknown between the Tenth day of January, 1962 and the Eleventh day of January, 1963 at Emu Park in the State of Queensland **REGINALD BASIL DURHAM** unlawfully and indecently dealt with , a girl under the age of 16 years.

COUNT 14

That on a date unknown between the Thirty-First day of December, 1960 and the Eleventh day of January, 1964 at Rockhampton in the State of Queensland **REGINALD BASIL DURHAM** unlawfully and indecently dealt with
REDACTED, a girl under the age of 16 years.



COUNT 15

That on a date unknown between the Thirty-First day of December, 1960 and the Eleventh day of January, 1964 at Rockhampton in the State of Queensland **REGINALD BASIL DURHAM** unlawfully and indecently dealt with **REDACTED**, a girl under the age of 16 years.

COUNT 16

That on a date unknown between the Thirty-First day of December, 1960 and the Eleventh day of January, 1964 at Rockhampton in the State of Queensland **REGINALD BASIL DURHAM** unlawfully and indecently dealt with **REDACTED**, a girl under the age of 16 years.

COUNT 17

CHRONOLOGICAL HISTORY**OF ORDERS:**

02/02/1998: Indictment presented.

24/07/1998: Application for stay of proceedings.

Order: CAV.

18/09/1998: 1. The application for a permanent stay is refused;

2. The trials are adjourned to the next callover but with the intimation that on the material placed before the court a trial at Rockhampton



on either indictment should not take place until sometime next year;

3. The parties are given liberty to bring an application for a change of venue on reasonable notice. On the material placed before the court, and subject to an order for a change of venue, I presently see no reason why the single indictment could not be brought on for trial immediately outside Rockhampton.



4. The parties are at liberty to raise the question of trial dates at any time with the court on reasonable notice.

15/02/1999: Nolle Prosequi entered.
