I, **MARK RICHARD KOCZAN**, Registrar of the District Court at **Rockhampton** in the State of Queensland, being duly authorised in this behalf do certify that the following information is contained in **Indictment No. D55A/99**.

OFFENCE/S IN FULL:

COUNT 1

That on a date unknown between the Twenty-second day of March 1968 and the Twenty-third day of March 1970 near Rockhampton in the State of Queensland **KEVIN LESLIE BAKER** unlawfully and indecently dealt with a girl under the age of seventeen years.

And further that was under the age of twelve years.

COUNT 2

That on a date unknown between the Twenty-second day of March 1968 and the Twenty-third day of March 1970 near Rockhampton in the State of Queensland **KEVIN LESLIE BAKER** unlawfully and indecently dealt with a girl under the age of seventeen years.

And further that was under the age of twelve years.

COUNT 3

That on a date unknown between the Twenty-second day of March 1968 and the Twenty-third day of March 1970 near Rockhampton in the State of Queensland **KEVIN LESLIE BAKER** raped .



COUNT 4

That on a date unknown between the Twenty-second day of March 1968 and the Twenty-third day of March 1973 near Rockhampton in the State of Queensland **KEVIN LESLIE BAKER** unlawfully and indecently dealt with ^{AYR} a girl under the age of seventeen years.

CHRONOLOGICAL HISTORY**OF ORDERS:**

30/08/1999: Indictment presented.

PLEA: Not guilty all counts. Jury sworn and empanelled.

ORDER: Jury discharged. Adjourn the matter to the next sittings of the District Court at Rockhampton in its criminal jurisdiction. Extend bail. Enlarge notices to Crown witnesses. Direct that I will sign a certificate under the Appeal Costs Fund Act.

13/12/1999: **PLEA:** Not guilty. Jury sworn and empanelled.

17/12/1999: **ORDER:** Nolle prosequi entered in relation to counts 2 and 3.

Accused discharged on counts 2 and 3.

Mistrial declared in relation to counts 1 and 4.

Order that trials in relation to counts 1 and 4 be adjourned to the next sittings of the District Court sitting in Rockhampton.

Bail enlarged.


Notices to Crown witnesses enlarged.
