OFFICERS REPORT

22/04/1998 CRIME CREATED BY RYAN, BRENDA GAY 7083 - GOLD COAST CHILD & SEX. A

The complainant's child mother attended the child abuse unit in March 1998. She requested the child be interviewed by police. The child was interviewed and made a disclosure of rape by the suspect. Police arranged for the child to be medically examined by DR Kerry SULLIVAN. There is no medical evidence to support the child's allegations. On 22/04/98 the suspect was interviewed and denied all allegations. The suspect stated he recalls the only day that the child had attended his address and was only alone with the child for no more than 2 minutes on that day. The complainant's child mother has been advised that police will not be proceeding with charges. There is insufficient evidence for any further police investigation or charging of the suspect. Due to the child's age and disability the child would not be a reliable witness and also lack of medical evidence to substantiate the offence.

EMAIL SUPPS: The complainant child was interviewed a second time by Det Sgt Parker of Gold Coast JAB on 18/3/99. The child did make a disclosure in relation to the suspect touching her bottom, however due to her disability, it was difficult to clarify what exactly the suspect did to her or exactly where he touched her. It is strongly suspected that this child has been sexually abused by the suspect to some extent. On 29/4/99 the complainant's mother provided a detailed statement regarding evidence of fresh complaint. A report was submitted to the office of DPP Southport for comment. Advice was later received that depending on the child's ability to give evidence, there could be sufficient evidence to proceed. The child was again interviewed by Det Sgt Parke in Brisbane with a worker from WILD. It was agreed that the child would not be capable of giving evidence as she would not be able to endure any cross examination. The matter was referred to the SCAN Team and it was decided that the matter be re-classified as substantiated and solved as it is in the victims interest not to proceed.
