On the 6th day of April 2006 I was rostered to work a 6a to 2p shift in the company of DS 4. TAYLOR, PCSC KINBACHER and PCC MINER. On this day at 6:35am a Police Powers and Responsibilities Act 2000 search warrant was executed upon the Boys Dormitory at Shalom Christian College. DFL were present when this occurred. Items of clothing were located and seized belonging to DFK DFL DFM DFK and voluntarily accompanied DFK police to the Townsville Station where I conducted interviews with and DFL in the company of DS TAYLOR. Support person was present during the interviews. Versions were obtained and DFL DFM were released.
