I, **Roger NEWMAN**, OF **SCU CIB PMC**, DO SOLEMNLY AND SINCERELY
 DECLARE THAT:

On the 16 June 1998 I received a file from Det. LOCKHART of the
 Alice Springs CIB.

The file was in relation to a complaint of sexual assault
 against a **AJD** and a Donald HENDERSON.

The complainant in this matter was **AJB** who
 currently lives in Alice Springs.

As a result of receiving the file I then conducted enquiries
 over the next two and a half years into the matter.

Further victims in relation to the matter were then uncovered
 with the rest of the allegations being against Donald Bruce
 HENDERSON the defendant now before the court.

The further victims of Donald HENDERSON who were identified
 were **AJD** who now lives in Perth, **AJE**
REDACTED and Carmen Victoria McMAHON who was known as Mary-Anne
 WHITTAKER at the time of the alleged offences.

Both of the **REDACTED** were spoken to in Darwin, whilst **AJD**
REDACTED lives in Perth.

After completing enquiries into the alleged victims I then travelled to **REDACTED** Queensland where I interviewed the alleged offender Donald Bruce HENDERSON on the 6 March 2001 in the company of DSC NICHOLSON.

Donald HENDERSON made no admissions during the interview and contacted his solicitor Mitchell CAVANAGH of RYAN & BOSSCHER of Maroochydore QLD.

Since that time I have received a letter from RYAN & BOSSCHER in relation to the allegations.

I have had no further dealings with the defendant.

(b) I HAVE READ THIS STATEMENT BEFORE SIGNING IT;


