ENQUIRY INTO ALLEGATIONS OF TRESPASS ON
RETTA DIXON HOME.

REDACTED :

Alleged entry on Sunday 11th Jan. and Monday 12th Jan. REDACTED admitted entry on both occasions. Claims not told that not permitted on Retta Dixon. Went over of own volition. REDACTED REDACTED went in first, through a hole. REDACTED was outside, but got inside thro' same hole. Missionary was away and REDACTED knew. Went to girl friend, REDACTED. Claimed he didn't want her, but REDACTED wanted him. Claims REDACTED knew and told REDACTED that Missionary not home. Claims did not know before that. REDACTED was asleep. REDACTED was with REDACTED. Girls woke REDACTED up. Girls did not expect him. He sat on side of the bed. Claims to have slept on a vacant bed. REDACTED woke him up and said, "Come on, let's go home."

On the 2nd. night, he was in camp when boys got in. REDACTED told him door was open. Went in this door and climbed partition. Lot of girls there, some on bed. Put his arms around her, but sure nothing more. Claims two nights were Saturday and Sunday. Did not know it was found out until Mr. Casey told him this morning. Has not entered since.

Decision:

Committal to northern Settlement away from "country" for three months' work without pay.

Admitted entry to dormitory one Sunday. Only sees REDACTED on road. Was on his own. Same night some school boys were there. Went in through door and over wall. One of schoolboys opened door. REDACTED told some schoolboys she wanted to see him. REDACTED conveyed the message. Took REDACTED into Mr. Johnson's place and went on to a mattress. REDACTED invited him to join him in Mr. Johnson's place. Missionary in bed. Claims nothing happened. Hasn't seen her for four weeks. Only went one time. Spoke to her at football. Also spoke to her down the road. First met her at basketball last season. Would not have gone there if REDACTED had not told him.

States now knows that permission should be obtained from Mr. Howell.

Decision:

Committal to northern Settlement away from "country" for three months' work without pay.

Admitted going to Retta Dixon Home on three occasions, Saturday, Sunday and Monday. Went to see REDACTED. REDACTED wrote note asking him to see her - out in the bush. Has seen her there. Knew he could get in through louvres. REDACTED was with him. REDACTED went with him, when REDACTED called him. REDACTED had idea to climb

in. He woke REDACTED. REDACTED woke REDACTED REDACTED lay on bed with REDACTED. Knew it was wrong. Knew Missionary was there. On second night, he and REDACTED told others to see girl friend. He wasn't first one in on Monday night. Spoke to REDACTED again. *blamed that REDACTED was on bed with REDACTED when he woke him up to go home.*
