As best as I recall

- 1) I have never seen any records that were housed at Mangrove in respect to any sort of abuse or sexual abuse other than some letters received over the years none of which had to do with minors. I do not think these letters were ever filed in any central place.
- 2) I have never spoken to or had any contact with anyone directly accusing anyone of sexual abuse of minors other than the recent publically held session at Mangrove.

Due to there being no records of what had occurred in the past I caused the sourcing of court records which you should have a copy.

I would hope that systems are now optimally put in place to screen any people that could be in contact with minors by way of a "working with Children" check. As I understand in the past we had difficulty obtaining these for volunteers however with the changes over the last year I believe it is now easier to get these. If possible I recommend that ALL residents, all paid staff, all teachers, all helpers in children's programs and regular volunteers / visitors be required to provide a working with children clearance.
