LT [REDACTED] D.O.B. REDA 73 OF [REDACTED] [REDACTED] ATTENDED ST. ANNS SPECIAL SCHOOL, 37 FINNIS STREET, MARION BETWEEN ABOUT 1984 UNTIL 1993. [REDACTED] REMEMBERS BRIAN PERKINS AND STATES THAT HE DID SOME BUS DRIVING ON THE HAPPY VALLEY ROUTE. LT [REDACTED] WAS LIVING AT HOME DURING THOSE DATES AT [REDACTED]. [REDACTED] NOW RESIDES AT [REDACTED] PHONE NUMBER [REDACTED]. [REDACTED] REMEMBERS BRIAN PERKINS WAS VERY GOOD WITH THE STUDENTS AT ST. ANNS. HE APPEARED TO BE HAPPY WHEN INTERACTING WITH THEM. AT THE TIME [REDACTED] BELIEVED THAT LT [REDACTED] HAD A GOOD RELATIONSHIP WITH BRIAN PERKINS. SHE NEVER WENT TO RESPITE CARE AT BRIANS HOME. WAS NOT ON HIS REGULAR BUS ROUTE BUT DID DO SOME WOODWORK WITH HIM IN THE WOODWORK SHED. SOMETIME BEFORE 1991 WHEN PERKINS LEFT THE SCHOOL LT [REDACTED] DISCLOSED TO [REDACTED] THAT BRIAN PERKINS HAD TOUCHED HER INAPPROPRIATELY ON HER BREAST. RED [REDACTED] DOESN'T REMEMBER UNDER WHAT CONTEXT THE SUBJECT WAS BROUGHT UP, BUT DOES REMEMBER JUMPING ON IT STRAIGHT AWAY AND GOING TO SEE THE PRINCIPAL CLAUDE HAMAM. LT [REDACTED] TOLD HER THAT THIS ASSAULT TOOK PLACE IN THE WOODWORK SHED OF THE SCHOOL. THE ALLEGATIONS WERE DISCUSSED WITH CLAUDE HAMAM IN A MEETING AT THE SCHOOL. AFTER THE MEETING [REDACTED] WAS CONFUSED AS TO WHETHER THE ASSAULT WAS DELIBERATE OR JUST AN ACCIDENTAL INCIDENT. IT WAS LEFT AT THAT AND SHE IS UNAWARE OF WHETHER PERKINS WAS EVER SPOKEN TO BY CLAUDE HAMAM. SHE HAS RECENTLY SPOKEN TO LT [REDACTED] ABOUT THE DISCLOSURE AND LT [REDACTED] IS UNABLE TO REMEMBER.

[REDACTED] REMEMBERS THAT IN ABOUT 1990 1991, SHE WAS IN HER CAR WITH LT [REDACTED] DRIVING HER TO WORK EXPERIENCE. AT THIS TIME LT [REDACTED] WAS INVOLVED IN SEXUAL EDUCATION LESSONS AT ST. ANNS. SHE WAS TALKING WITH LT [REDACTED] ABOUT WHAT SHE HAD LEARNED IN THE LESSONS WHEN LT [REDACTED] DISCLOSED THAT LH [REDACTED] WAS TRYING TO TOUCH LT [REDACTED] IN THE AREA OF HER VAGINA AND HE WANTED LT [REDACTED] TO TOUCH HIM. SHE PRESUMED IT WAS HIS PENIS THAT HE WANTED LT [REDACTED] TO TOUCH. FROM WHAT LT [REDACTED] TOLD REDAC SHE ASSUMED THAT THIS HAD HAPPENED MORE THAN ONCE AND OCCURRED IN THE COMPUTER ROOM OF THE SCHOOL.

[REDACTED] SPOKE WITH MARTIN AARTSEN ABOUT THE ALLEGATIONS AND MARTIN TOLD HER THAT HE WOULD DEAL WITH IT. IN THE YEAR 2000 LT [REDACTED] AND HER SISTER [REDACTED] MOVED OUT OF HOME. [REDACTED] REMEMBERS THAT SOMETIME AFTER THEY HAD MOVED OUT OF HOME AND PROBABLY THAT SAME YEAR THAT SHE RECEIVED A TELEPHONE CALL FROM [REDACTED] WHO IS 5 YEARS OLDER THAN LT [REDACTED]. [REDACTED] TOLD HER THAT LT [REDACTED] WAS HAVING NIGHTMARES ABOUT THE SEXUAL ABUSE AT ST. ANNS.

[REDACTED] WENT AND SPOKE WITH LT [REDACTED] AND IT WAS THEN THAT LT [REDACTED] TOLD HER ABOUT FURTHER INCIDENTS WITH LH [REDACTED]. SHE TOLD HER THAT WHEN LH [REDACTED] AND HER WERE IN REDACTE [REDACTED] CLASS. LT [REDACTED] TOLD HER THAT LH [REDACTED] HAD WANTED
