REDACTED STATES SHE APPROACHED THE SCHOOL AROUND THE
SAME TIME AS PERKINS HAD BEEN FOUND IN POSSESSION OF
PHOTOGRAPHS OF LH AND MX REDACTED WAS ALSO
CONCERNED ABOUT HER HUSBANDS BEHAVIOUR AS HE HAD BEEN
ALLOWED TO ASSIST AT THE SCHOOL AS A BUS DRIVER AND A TYPE

CONCERNED WHEN HER SONE EXHIBITED UNUSUAL SEXUAL BEHAVIOURS
FAR BEYOND WHAT YOU WOULD EXPECT FROM A CHILD OF HIS AGE
AND INTELLECT. SHE ALSO ADVISED THAT AT ONE STAGE HER

WAY. SHE IS FRIENDS WITH REDACTED AND WILL
CONSULT HIM RE COUNSELLING FOR LU IF IT IS BELIEVED IT
CAN ASSIST. WILL CONSULT WITH DET. INSP. MCCAFFREY RE
