- RE IS A RECIPIENT OF THE LETTER SENT BY ARCHBISHOP WILSON.
- SHE STATES THAT OVER THE EASTER WEEKEND THE FAMILY HAD MS AT HOME. MS CURRENTLY RESIDES IN REDACTED RE USED TO WORK WITH BRIAN PERKINS AND KNOWS HIM WELL. WHILE BRIAN WAS EMPLOYED AS A BUS DRIVER WITH ST ANNES HE HAD REGULAR CONTACT WITH MS
- SHE WAS A VERY WELL DEVELOPED GIRL PHYSICALLY.
- RED STATES THAT REGULARLY MS WOULD BE DROPPED OFF BY BRIAN AT HOME BETWEEN 20 AND 30 MINUTES LATE. ALTHOUGH AT THE TIME THEY HAD NO SUSPICIONS, SINCE THE LETTER THEY DECIDED TO ATTEMPT TO SPEAK TO MS ABOUT HER EXPERIENCES WITH PERKINS.
- RE SPOKE TO MS OVER THE EASTER WEEKEND RED HAD PREVIOUSLY COMMUNICATED WITH A PSYCHOLOGIST WHO ADVISED HER ON AN APPROPRIATE WAY OF GETTING INFORMATION FROM MS WITHOUT "LEADING" HER TOO MUCH.
- MS DISCLOSED TO RED THAT PERKINS HAD FONDLED HER BREASTS AND HAD TOUCHED HER VAGINAL AREA. NO INDICATION OR DISCLOSURE OF PENETRATION.
- MS COMMUNICATES QUITE WELL VERBALLY.
- RE HAS STATED THAT SHE DOES NOT WANT MS INTERVIEWED OR SPOKEN TO BY POLICE REGARDING THE DISCLOSURES.
- RODNEY ADVISED RED THAT HER WISHES WOULD BE RESPECTED BUT THAT THE POLICE ARE WILLING TO CONDUCT FURTHER INVESTIGATION IF SHE RECONSIDERS HER POSITION.
