Q2 Thankyou Karen, thankyou LH LH I've got some further questions to ask you in relation to some photos, that have been previously shown to you at another interview. And I'll just lay them out on the table for you to look at.

Now LH as you can see, these photos have all got a blanket in them, do you agree with that?

A2 Yes

Q3 Can you tell me where these photos were taken?

A3 In Brians back yard

Q4 I'll just repeat that again, "in Brians back yard."

A4 Yep

Q5 And can you tell me who was there.....?

A5 Brian and.....

Q6 Hang on, just,just hang on a sec, just, wait until I ask the questions and then you answer it all right, who who was there when the photos were taken?

A6 Brian and Rob

Q7 And can you tell me where that the blanket that, that's in these photos came from?

Where did the blanket come from?

A7 In his bedroom

Q8 And, I'll repeat that again, "in his bedroom."

A8 Yep.in his bedroom.

Q9 Can you remember who got that blanket from the bedroom?

A9 Brian did

- Q10 Brian did
- A10 Yep
- Q11 Now, when were these photos taken?
- A11 On the weekend
- Q12 And, were they taken on separate days on a weekend or all in one time
- A12 All in one time
- Q13 All in one time
- A13 Yep
- Q14 And, who is the picture, who is the young man in the picture
- A14 LH
- Q15 And that's you, is that right?
- A15 Me, Yep.
- Q16 Ok, that's for those photos there LH, this is a second lot of photographs can you tell me whose in the picture?
- A16 Its me
- Q17 And that's LH
- A17 And that's LH
- Q18 Ok, now do you agree with me that all these photos you can see a chair or a portion of a chair, just have a look at them properly.
- A18 A what, chair
- Q19 chair, can you see a chair in these photographs
- A19 Yeah
- Q20 Right
- A20 Chair, chair.
- Q21 Alright, and there's a couple over here, it's a bit hard to see but you were sitting down
- A21 Yep

Q22 Is there a chair there

A22 Yep, and chair there

Q23 That's right

So do you agree and you having a look at all those that there is a chair in these photos?

A23 Yeah,yeah, yep.

Q24 Very good, where were these photos taken?

A24 In his back yard

Q25 In whose back yard

A25 Brians back yard

Q26 And, who was there when they were taken

A26 Ted, no, rob and Brian

Q27 Rob and Brian

A27 Yep

Q28 Rob and Brian were there

Again were these photos taken seperately or all in one go

A28 All in one go

Q29 And would that have been on a weekday or a weekend

A29 Weekend

Q30 Ok that's those photos there

Now, we've got 5 photographs here, whose in the picture

A30

Q31 And that's you

A31 Yep

Q32 Ok, where were these pictures taken

A32 Brian's backyard

Q33 Brian's backyard

A33 Yep

Q34 and who was there when the photos were taken

A34 Rob and Brian

Q35 Rob and Brian

I'm only repeating just so its clearer for the the tape, do you understand that

A35 Yep.

Rob and Brian

Q36 Rob and Brian

A36 Yep

Q37 Thankyou

And were these taken all in one go or were they taken a couple of times or more.

A37 Not in one go

Q38 So they were taken on, on one or more times, on more than one time

A38 Yeah

Q39 Right

And when would that have happened,

On a weekday or a weekend

A39 Weekend

Q40 Thankyou

Ok the last photos , there's just two of them. Whose the person in the photograph

A40

Q41 And that's you

A41 Yep

Q42 Do you notice that there's some bathers that your wearing, whose bathers do they belong to

A42 Brian

Q43 They belong to Brian

A43 Yep

Q44 Where did he get those bathers from?

A44 In his bedroom

Q45 Did he get those bathers

A45 Yep

Q46 Who asked you to put them on

A46 Brian

Q47 Who else was there when you were wearing those bathers

A47 Rob and Brian

Q48 Both of them were there

A48 Yep

Q49 And, whereabouts have those photos been taken

A49 Out the backyard

Q50 In the back yard

A50 In Brians back yard, yep.

Q51 In Brians backyard

A51 Yep

Q52 Alright thanks very much for that [LH] that's all I need to ask you about and that concludes the interview at 3.08 p.m. by my watch, thankyou.
