OFFENCE DETAILS - SUMMARY OF EVIDENCE

COUNTS 1 AND 2.ON 26/8/91 POLICE MOSHEEV AND CARR AS A RESULT OF RECEIVING INFORMATION ATTENDED AT 17/93 FOLKESTONE ROAD, DOVER GARDENS AND SPOKE WITH THE OCCUPANT, BRIAN PERKINS. AS A RESULT OF THAT CONVERSATION WE THEN SEARCHED THESE PREMISES AND LOCATED NUMEROUS PHOTOS AND NEGATIVES. TWO NEGATIVE ROLLS ENCLOSED IN CANNISTERS WERE LOCATED WITH THE NAMES OF [MX] AND [LH] WRITTEN ON THEM. THESE WERE SEIZED AND TAKEN TO PHOTOGRAPHICS WHERE THEY WERE DEVELOPED. THE PHOTOS SHOWED TWO YOUNG MALES IN STAGES OF UNDRESS AND TOTALLY NAKED. FURTHER ENQS. WERE CONDUCTED TO ASCERTAIN WHO THE MALES WERE. POLICE THEN REATTENDED AT THE DOVER GARDENS ADDRESS BUT THE SUSPECT HAD VACATED THE PREMISES AND IT WAS BELEIVED THAT HE HAD GONE INTERSTATE. THE PHOTOS OF THE MALES SHOWED THEM TO BE MENTALLY HANDICAPPED.

THE NAMES OF THE TWO YOUNG MALES IS KNOWN AND THEIR WHEREABOUTS IS KNOWN.COUNT 3POLICE SPOKE WITH ONE OF THE VICTIMS, [LH] AT THE ST ANNES SPECIAL SCHOOL SITUATED AT 37 FINNIS STREET, MARION. A STATEMENT WAS TAKEN AND IT WAS ASCERTAINED THAT HE SPENT TIME AWAY FROM THE SCHOOL WITH PERKINS. PERKINS WAS EMPLOYED AS A BUS DRIVER BY THE SCHOOL AND [LH] STATED THAT HE MET PERKINS IN WOODWORK CLASSES AND ON THE BUS. HE STATED THAT HE HAD BEEN BACK TO PERKINS UNIT AT DOVER GARDENS AND THAT PHOTOS HAD BEEN TAKEN OF HIM WITH NO CLOTHES ON. HE FURTHER STATED THAT HE HAD GONE WITH PERKINS TO A FRIEND OF PERKINS WHERE HE WAS INVOLVED IN SUCKING BRIANS PENIS AND THAT BRIAN SUCKED HIS PENIS. HE FURTHER STATES THAT ON ANOTHER OCCASION HE WAS WITH BRIAN AND OTHER MALES WHEN THEY WERE ALL NAKED TOGETHER AND THAT THESE OTHER PERSON INCLUDING BRIAN TOUCHED HIS PENIS BUT HE DID NOT GET AN ERECTION.COUNT 4AT ABOUT 6.30 a.m. ON FRIDAY THE 10th of SEPTEMBER, POLICE MOSHEEV, BLANDFORD, MARTIN AND FELTUS ATTENDED AT 12 VALLEYVIEW CRESCENT, HACKHAM WEST AND SPOKE WITH SUSPECT, BRIAN PERKINS. AS A RESULT OF THAT CONVERSATION POLICE SEARCHED HIS PREMISES WHICH CONSISTED OF A CARAVAN AND A SHED. NUMEROUS ITEMS WERE LOCATED AND SIEZED INCLUDING PORNOGRAPHIC BOOKS OF MALE CHILDREN DEPICTING THEM WITH ERECTIONS AND TOUCHING EACH OTHER. IT IS SUSPECTED THAT NUMEROUS VIDEOS SEIZED WILL ALSO SHOW FILM OF CHILDREN DEPICTING SEXUAL ACTS. THESE ITEMS WERE LOCATED IN AMONGST THE PERSONAL BELONGINGS OF THE SUSPECT. OTHER ITEMS INCLUDING LETTERS WRITTEN TO PERKINS IN RELATION TO SEXUAL ACTS WITH CHILDREN AND THEMSELVES AS WELL AS PHOTOS OF CHILDREN WITH DETAILS WRITTEN ON THE BACK DETAILING ACTIVITIES WITH THESE CHILDREN SUCH AS "I've fucked him several times" AND "he's got a nice bum". FURTHER ENQUIRIES TO BE CONDUCTED.OFFENDERS VERSIONPERKINS STATED TO POLICE THAT HE WAS MINDING THESE ITEMS FOR SOMEONE ELSE BUT ADMITTED THAT HE HAD VIEWED SOME OF THE VIDEOS. HE STATED HE WANTED TO TELL POLICE WHO HE WAS MINDING THE ITEMS FOR BUT THAT HE WANTED TO CONSULT A SOLICITOR BEFORE HE SPOKE TO POLICE. HE REFUSED TO ANSWER ANY QUESTIONS INTO ALLEGATIONS RE COUNTS 1 to 3.
