DETAILS OF OFFENCE

In August 1991, Police attended an address at Douar Gons and located two rolls of film which were subsequently developed and found to be child pornography. Suspect Perkins decamped this address.

In Sept. 1993, Police located the suspect at a Hackham West address. A search was conducted and child pornography located. Perkins was arrested and eventually given court bail. He absconded and a warrant of apprehension was issued for his arrest.

An investigation conducted by Police relative to the material located revealed more serious offences of prurient interest and indecent assault committed by Perkins. These offences are included in the warrant of apprehension.

This investigation is currently being reviewed by members of Operation Cormorant at Child Exploitation Investigation Section.

The extradition of Perkins to this state has been verbally approved by Assistant Comm. White.
