Gratify Prurient Interest. (Section 58(1)(b) of the Criminal Law Consolidation Act, 1935).

Particulars of Offence

Brian Bertram Morris Perkins between the 1st day of January, 1987 and the 26th day of August, 1991 at Dover Gardens, caused or induced LH [redacted], a person under the age of 16 years, to expose part of his body on an occasion when a blanket was put on the ground in the back yard at Dover Gardens and photographs were taken. NC

Second CountStatement of Offence

Gratify Prurient Interest. (Ibid).

Particulars of Offence

Brian Bertram Morris Perkins between the 1st day of January, 1987 and the 26th day of August, 1991 at Dover Gardens, caused or induced LH [redacted], a person under the age of 16 years, to expose part of his body on an occasion when a chair was in the back yard and photographs were taken. NC

Third CountStatement of Offence

Indecent Assault. (Section 56 of the Criminal Law Consolidation Act, 1935).

Particulars of Offence

Brian Bertram Morris Perkins between the 1st day of January, 1987 and the 26th day of August, 1991 at Prospect, indecently assaulted LH [redacted], a child under the age of 16 years, on an occasion of an alleged party at Ted Nicholls' place. NC

Fourth CountStatement of Offence

Unlawful Sexual Intercourse. (Section 49(3) of the Criminal Law Consolidation Act, 1935).

Particulars of Offence

Brian Bertram Morris Perkins between the 1st day of January, 1987 and the 26th day of August, 1991 at Dover Gardens, had anal sexual intercourse with LH [redacted] LH [redacted], a child under the age of 16 years. NC

Fifth CountStatement of Offence

Gratify Prurient Interest. (Section 58(1)(b) of the Criminal Law Consolidation Act, 1935).

Particulars of Offence

Brian Bertram Morris Perkins between the 1st day of January, 1987 and the 26th day of August, 1991 at Dover Gardens, with a view to gratifying prurient interest, caused or induced LH [redacted] and LB [redacted] both under the age of 16 years to expose part of his body on an occasion when a video camera was used. NC

Sixth CountStatement of Offence

Indecent Assault. (Section 56 of the Criminal Law Consolidation Act, 1935).

Particulars of Offence

Brian Bertram Morris Perkins between the 1st day of January, 1987 and the 26th day of August, 1991 at Dover Gardens, indecently assaulted MR , a child under the age of 12 years. NG.
