ORIGINAL

The INFORMATION of the undersigned A MEMBER OF THE POLICE FORCE of STURT CRIMINAL JUSTICE SECTION who on the 12TH day of JULY, 2002, states that

Brian Bertram Morris PERKINS (DOB 20/2/1936) of 12 Valleyview Crescent, HACKHAM WEST SA 5163 (defendant)
and Geoffrey Paul BARTON (DOB 9/4/1949) of 7/45 Avenue Road, HIGHGATE SA 5063 (defendant)

1. That between the 1st day of January, 1987 and 26th day of August, 1991 at DOVER GARDENS in the said State Brian Bertram Morris PERKINS, with a view to gratifying prurient interest, caused or induced LH [redacted] a person under the age of 16 years to expose part of his body on an occasion when a blanket was put on the ground in the back yard at Dover Gardens and photographs were taken.
Section 58a of the Criminal Law Consolidation Act, 1935.
This is a Minor Indictable offence.
2. That between the 1st day of January, 1987 and 26th day of August, 1991 at DOVER GARDENS in the said State Brian Bertram Morris PERKINS, with a view to gratifying prurient interest, caused or induced LH [redacted] a person under the age of 16 years to expose part of his body on an occasion when a chair was taken out into the back yard at Dover Gardens and photographs were taken.
Section 58a of the Criminal Law Consolidation Act, 1935.
This is a Minor Indictable offence.
3. That between the 1st day of January, 1987 and 26th day of August, 1991 at DOVER GARDENS in the said State Brian Bertram Morris PERKINS, with a view to gratifying prurient interest, caused or induced LH [redacted] and LB [redacted] both under the age of 16 years to expose part of his body on an occasion when a video camera was used.
Section 58a of the Criminal Law Consolidation Act, 1935.
This is a Minor Indictable offence.
4. That between the 1st day of January, 1987 and 26th day of August, 1991 at DOVER GRADENS in the said State, Brian Bertram Morris PERKINS indecently assaulted LH [redacted] a child under the age of 16 years, on an occasion of an alleged party at Ted Nicholls' place.
Section 56 of the Criminal Law Consolidation Act, 1935.
This is a Minor Indictable offence.
5. That between the 1st day of January, 1987 and 26th day of August, 1991 at DOVER GARDENS in the said State, Brian Bertram Morris PERKINS, had anal sexual intercourse with LH [redacted] a person under the age of 16 years.
Section 49(3) of the Criminal Law Consolidation Act, 1935.
This is a Major Indictable offence.
6. That between the 1st day of January, 1987 and 26th day of August, 1991 at DOVER GARDENS in the said State, Brian Bertram Morris PERKINS and Geoffrey Paul BARTON indecently assaulted MR [redacted] a child under the age of 12 years, on an occasion when a video camera was used.
Section 56 of the Criminal Law Consolidation Act, 1935.
This is a Minor Indictable offence.
