RE COUNT 1 AND COUNT 2.

AS IN THE A.P. NEGATIVES WERE SEIZED FROM THE ADDRESS AT DOVER GARDENS AND WERE DEVELOPED. DUE TO THE LENGTH OF TIME SINCE THIS WAS FIRST DONE I HAVE BEEN UNABLE TO FIND THE PHOTS DUE TO ANUMBER OF REASONS INCLUDING THAT THE FILE WAS TAKEN OVER FROM ME BY OTHER DETECTIVES WHILST ON 4 MONTHS SICK LEAVE. MYSELF ALONG WITH DETECTIVE CARR AND DET. SGT JOE CLARKE CAN GIVE EVIDENCE THAT WE SAW THESE PHOTOS AS WELL AS THE PRINCIPAL FROM ST ANNES SPEACIAL SCHOOL AND NE [REDACTED]. PHOTOS HAVE BEEN SENT BACK FROM LONDON WHEREBY LONDON POLICE HAD ARRESTED TWO PERSONS OVER THERE FOR SEXUAL OFFENCES. THESE PHOTOS ARE THE SAME AS THE ONES THAT WE WERE IN POSSESSION OF. I HAVE THESE PHOTOS. BOTH THESE BOYS ARE MENTALLY INCAPACITATED AND WILL NOT BE ABLE TO GIVE EVIDENCE.

RE COUNT 3

I AM AWARE THAT WE HAVE PROBLEMS WITH THIS ONE AS WE HAVE NO VICTIM OR WITNESS WHO CAN GIVE EVIDENCE ABOUT THIS MATTER. DUE TO THESE CIRCUMSTANCES I HAVE NOT CHARGED RAPE BUT INDECENT ASSAULT AS THERE MAYBE A CHANCE THAT HE MAY PLEAD TO THIS. IF NOT THEN THE MATTER WILL HAVE TO BE DROPPED. THE CONDITION OF THE MAIN VICTIM LH [REDACTED] HAS NOT BEEN ASCERTAINED AT THIS STAGE AND FURTHER ENQS. WILL HAVE TO BE MADE TO SEE IF HE IS IN A POSITION TO PROVIDE EVIDENCE.

RE COUNT 4.

EXPLICIT PORNOGRAPHIC MAGAZINES OF BOYS WAS LOCATED IN THE CARAVAN AND THESE HAVE BEEN SEIZED. NUMEROUS VIDEOS AND PAPERS AND PHOTS HAVE BEEN SEIZED BUT AT THIS STAGE WE HAVEN'T HAD TIME TO GO THROUGH ALL THE EVIDENCE.

IT IS LIKELY AFTER FURTHER INVESTIGATIONS THAT FURTHER CHARGES WILL BE LAID.
