Summary Procedure Act, 1921 - Section 101

The INFORMATION of the Police of ADELAIDE who on the 4TH day of JANUARY, 1994, states that

1. That between the 6th day of October 1992 and the 12th day of October 1992 at KLEMZIG in the said state, Robert Kingsley HAWKES and Kenneth William GLENCROSS, with a view to gratifying prurient interest, caused or induced REDACTED, a person under the age of 16 years to expose part of his body.
Section 58a of the Criminal Law Consolidation Act, 1935.
This offence is designated a minor indictable offence.
2. That on or about the 9th day October 1992, at KLEMZIG in the said state, Robert Kingsley HAWKES and Kenneth William GLENCROSS with a view to gratifying prurient interest, caused or induced REDACTED, a person under the age of 16 years, to expose a part of his body.
Section 58a of the Criminal Law Consolidation Act, 1935.
This offence is designated a minor indictable offence.
3. That on or about the 9th day of October 1992 at KLEMZIG in the said state, Robert Kingsley HAWKES and Kenneth William GLENCROSS, with a view to gratifying prurient interest, caused or induced REDACTED, a person under the age of 16 years to expose a part of his body.
Section 58a of the Criminal Law Consolidation Act 1935.
This offence is designated a minor indictable offence.
4. That between the 30th day of June 1990 and the 26th day of August 1991 at DOVER GARDENS in the said state, Robert Kingsley HAWKES and Brian Bertram Morris PERKINS, with a view to gratifying prurient interest, caused or induced LH, a person under the age of 16 years to expose part of his body.
Section 58a of the Criminal Law Consolidation Act, 1935.
This offence is designated a minor indictable offence.
5. That between the 30th day of June 1990 and the 26th day of August 1991 at DOVER GARDENS in the said state, Brian Bertram Morris PERKINS, had anal sexual intercourse with LH, a person under the age of 16 years.
Section 49(3) of the Criminal Law Consolidation Act, 1935.
This offence is designated a major indictable offence.

6. That between the 30th day of June 1990 and the 26th day of August 1991 at DOVER GARDENS in the said state, Brian Bertram Morris PERKINS, had sexual intercourse with LH [REDACTED], a person under the age of 16 years, by performing an act of fellatio upon him. Section 49(3) of the Criminal Law Consolidation Act, 1935. This offence is designated a major indictable offence.

7. That on the 10th day of September 1993, at HACKHAM in the said state, Brian Bertram Morris PERKINS, had in his possession, material namely photographs, film and magazines involving children that was indecent and offensive. Section 33(3) of the Summary Offences Act, 1953. This offence is designated a summary offence.
