I am a Constable of Police, identification number 36980 of the South Coast Family Violence Investigation Section and am commencing this statement at about 2.05 p.m. on Wednesday the 1st December 2010.

As a result of information received, I attended the REDACTED Primary School, REDACTED at about 2.10 pm on Friday the 20th August 2010 in company with Detective Brevet Sergeant Dean Millman. Millman then had a conversation with the principal of the school, [REDACTED] and a class teacher [REDACTED]

Detective Brevet Sergeant Millman then spoke with [CDH] and [CDG] and whilst speaking with them we were informed that [CDF] had arrived at the school to collect the students.

I went to the car park with Detective Brevet Sergeant Millman and saw a white taxi bus with a male person in the driver's seat and some children already seated in the rear of the bus. Detective Brevet Sergeant Millman spoke with [CDF] and advised him he was under arrest.

At about 3.15 pm Senior Constable Paul Adams arrived at the school with a video camera. [CDF] was conveyed back to Christies Beach Police Station.

I was requested by Detective Brevet Sergeant Dean Millman of the Family Violence Investigation Section to obtain a statement from [REDACTED] 65 years. [REDACTED] attended the Christies Beach Police Station on Tuesday the 23rd November 2010 at about 4.50 p.m. whereby I obtained a typed statement from her detailing information about [REDACTED]'s grand son [CEN]
