

I am a Senior Constable of police, identification number 59499 currently stationed at Christies Beach. I commenced this statement at 2.36 p.m. on Friday 20th August 2010 at CHRISTIE DOWNS.

On Friday 20th August 2010 I was conducting uniform mobile patrol in company with Probationary Constable BIRT. At 1.35 p.m. we attended at the

On arrival at the school we were met by the Principal who introduced herself to us as

REDACTED She took us into her office where we were advised that the alleged victim's name is **CDI** **REDACTED** dob **REDACTED** 2004. We were also introduced to the parents of the alleged victim, **CDG** **REDACTED** dob **REDACTED** 1972 and **CDH** **REDACTED** dob **REDACTED** 1973, and the alleged victims teacher, **REDACTED** dob **REDACTED** 1961. The mother of the victim was extremely distressed and crying.

At that time the parents gave me some information in regards to the victims behaviour over the previous three weeks. **CDG** **REDACTED** stated that the victim had been complaining of a sore bottom for about three weeks. In the previous two weeks the victim had been bed-wetting which his mother advised was unusual. The parents also stated that the victim had been sad and more emotional than usual. **CDG** **REDACTED** stated that the victim had stated he was scared to get on the school bus. The parents advised me that the victim is the last person on the bus at the end of the day on most days of the week.

I then spoke to **REDACTED** who is the victims teacher. She stated that the victim had seemed sad to her on this date and she asked him if he was alright. **REDACTED** stated that the victim had told her that he was sore in his tummy and also pointed to his penis saying he was sore there also.

The victim went on to tell **REDACTED** that he played "hide and seek" on the bus. He said something about **CDF** **REDACTED** " in his bottom and putting his hands in his hole. The victim further disclosed to **REDACTED** that **CDF** **REDACTED** pulls his own pants down and the victim

indicated that ^{CDF} then put the victims hands on his penis and rubbed them around. The victim also told ^{REDACTED} that they had "cuddles"

^{REDACTED} showed police a two dimensional picture of a person similar to one that she had shown the victim and that he had indicated various things on that person to her.

It was identified to police at that time that ^{CDF} is the school bus driver.

^{REDACTED} stated that the victim hadn't wanted to get on the school bus for about two weeks.

I recorded all of this information in my police notebook at the time I was talking to the parents and the teacher.

A short time later I spoke to Brevet Sergeant MILLMAN and Constable DUNLEVEY members of the Christies Beach Criminal Investigation Branch who attended the school.

I passed on the information that I had received from the parents and teacher and then Probationary Constable BIRT and I left the school.
