OFFENCE DETAILS - SUMMARY OF EVIDENCE

Summary of Evidence: Victim **BYN**, alleges sexual abuse occurring from march 1991 and continuing from that time for a number of years. Offender re these matters being Robert Brandenburg his then leader in an organisation called the Church of England Boys Society (CEBS) The offences are alleged to have occurred at Brandenburgs home at **REDACTED** and at camp sites under the control of the Anglican Church. The offences started with fondling of the victim's penis and continued through with acts including masturbation and oral sex. One particular offence occurred on the night of the **REDACTED** social at a camp site at Hoyleton (26/6/93) The deft Brandenburg when arrested made full admissions in relation to the incident and his diary when seized was found to include a reference on 26/6/93 to being with the victim.

Victim version

Victim re this matter is **BYN** born 31/12/1976 who states that he joined the Church of England Boys Society (CEBS) at magill and that at the time of joining he met a person named Robert Brandenburg who was the leader of that group. In March of 1991 whilst at Brandenburgs home at **REDACTED** Brandenburg fondled his (the victim's) penis and from this time on through until he was older than 17 years Brandenburg continued to indecently assault him on a regular basis. These incidents escalated to include Brandenburg performing acts of oral sex upon him (victim) The acts occurred at Magill and also at church camp sites including a site at Hoyleton. The victim recalls on the night he should have been at **REDACTED** being with Brandenburg at Hoyleton where Brandenburg performed oral sex upon him. The victim states that sexual incidents with Brandenburg occurred on a regular basis.

Witness: The witness re this matter is **REDACTED** Parish who is able to state that Robert Brandenburg was the leader CEBS at **REDACTED** and that **BYN** was a member of the CEBS.

Witness 2: Witness re this matter is **REDACTED** of **REDACTED** who is able to state that the school had a formal on **REDACTED**.

Police version: On Monday 24th may 1999 member of the Child Exploitation Investigation section **REDACTED** attended at **REDACTED** at which location they arrested the deft re this matter Robert Malcolm Brandenburg. Brandenburg's prems was also searched and a number of items seized including diaries. The 1993 diary was found to include an entry on 26th June 1993 which stated **REDACTED** The det was conveyed to the Adelaide Investigations office where a video interview was conducted. at the conclusion of which the deft was taken to the City Watch House where he was searched and charged.

Deft version: Deft made full admission in relation to this matter and stated that he believed that he sexually abused the victim on at least 3 occasions per month including masturbation and oral sex. The deft also made further admission to 6 other victims enquires relating to same are currently continuing. Reason for arrest: Protection of victims, ensure appearance, prevent repetition.
