**Brief notes:** Discharged from Townsville hospital. Admitted 20/3/06, Query Appendicitis (not confirmed). Prescribed antibiotics. No diagnosis. Referral to Amy – Query psychosomatic origin.

**Brief notes:** Consultation re recent hospitalization. Discussed possible somatisation of distress. Discussed strategies for dealing with bullying. Police contacted by Chris S. Discussed likely police procedures. Decisional counseling re making a complaint to police. <sup>CLF</sup> wishes to make a complaint. Organised to accompany <sup>CL</sup> to Townsville Police Station tomorrow. Parents contacted. <sup>CL</sup> remained at H&W centre throughout the day. Arrangements made for <sup>CLF</sup> to transfer to Crystal Creek for evening. To travel back to SCC with houseparents tomorrow morning to attend interview with JAB.

**Brief notes:** Arranged appointment with JAB for 1:00pm. Cancelled at parent's request. Telephone conversation with Ian (JAB) who is concerned that <sup>CL</sup> may be being pressured into making a complaint. Arranged meeting for tomorrow morning to outline police procedures. Meeting to be held at SCC - approved by Chris S.

**Brief notes:** Informal meeting with <sup>CLF</sup> and Ian (JAB) (11:30). Ian discussed procedures of interviewing, investigation, and possibility of court appearances. Asked <sup>CLF</sup> if she had any questions about what would happen if she chose to make a complaint. <sup>CLF</sup> was mainly concerned about possibility of requiring a medical examination.

**Brief notes:** Met with <sup>CLF</sup> parents – <sup>EAL</sup> and <sup>EAM</sup> – at Iris Clay Hostel (6:30 – 8:15). Mo & Fo unhappy about <sup>CLF</sup> meeting with JAB last Friday. Explained purpose of meeting and fact that <sup>CLF</sup> was not interviewed & meeting was not recorded. Discussed referral to appropriate sexual assault support services for counseling and support for <sup>CLF</sup> and other family members. Discussed referral to family therapy services. Mo & Fo raised concerns about communication and supervision problems (referred to principal). Also raised concerns about other people telling them of similar assaults at Shalom (encouraged referral to principal). <sup>CLF</sup> was interviewed today at Townsville Police Station. Mo & Fo unhappy with police involvement.
