All staff employed by Scouts NSW work in child related roles regardless of the title of their position. Cooks, Marketers, Administrators etc all work and run child related activities on our campsites as well as on major events as a core part of their employment. Some of our campsites are over 160 hectares in size and quite frequently children can be in contact with adult staff in a totally unsupervised situation. Scouts NSW are champions of child protection and take every effort to ensure that all children engaged with Scouting are not put at risk. We would appreciate if you could cooperate in this instance.
