Concern:

Caller said mother and AF came in to the station today at about 5:50pm today. Mother told caller that during the way back home from vacation centre, AF disclosed to his mother that Jonathan Lord, one of the carers at the vacation centre talked to AF about tounsel hockey game (which is talking about we kissing) and asked AF if have you ever tried it? And AF said he had not and he did not want to. Then AF also disclosed to mother that he was sitting on Jonathan's lap and Jonathan rubbed outside of AF pants (groin area). Caller added that AF told mum that Jonathan used his hand and he puts it in AF jeans pocket and then he rubbed up and down in AF pocket. AF also said to his mum that Jonathan put his hands inside AF shirt and touched AF chest and stomach.

Caller said mother only has been spoken to at this stage. Caller also said mother is not going to send AF to the vacation centre again. Caller
