He cares for the 9 year old VIC on Saturdays between 8:30am & 4pm, and occasionally once every fortnight between the hours of 7pm and 11pm. He has cared for the VIC for approximately 1 year.

About 8pm on Thursday 13 October 2011, the POI and his mother Jill YANKOS attended the VIC's unit at [REDACTED]. The POI's

mother works with the NOK at [REDACTED] Real Estate [REDACTED]. The POI disclosed to the NOK that there was an allegation that he acted inappropriately with a child on a bus that police were currently investigating. The POI's mother asked the NOK to provide the POI with a character reference in relation to this allegation. The NOK was happy to provide a reference at this time, however politely told the POI he would be stood down until the matter was finalised. The NOK was concerned after the POI stated he couldn't eat or sleep and that his life had been wrecked.

When the POI and his mother left the location, the NOK had a conversation with the VIC.
 The NOK said, "Does John touch your willy?"
 The VIC said, "yes."
 The NOK said, "Does John show you his willy?"
 The VIC said, "no mum."
 The NOK said, "how many times has he done it?"
 The VIC said, "i can't remember."

The VIC appeared distressed and embarrassed and would only give one word responses. The NOK asked further questions and confirmed the POI did not touch the VIC's bottom. She asked the VIC if his willy stands up when John touches him and he replied sometimes. The VIC did ask the POI to stop and stated it had not happened once but every Saturday. The VIC further stated the

POI touches and rubs the VIC's penis. The VIC remains clothed and the POI does not have direct contact with the VIC's penis.

The last incident is believed to have occurred on Saturday 1 October 2011.

Due to a similar investigation being carried out the YMCA have been notified and have suspended the POI indefinitely. DOCS have been notified. Kogarah JIRT are investigating the POI for recent and similar matters and will have carriage of this investigation.
