As you are aware John Lord's Plea Hearing is due in court in 1 week - Tuesday 1st May.

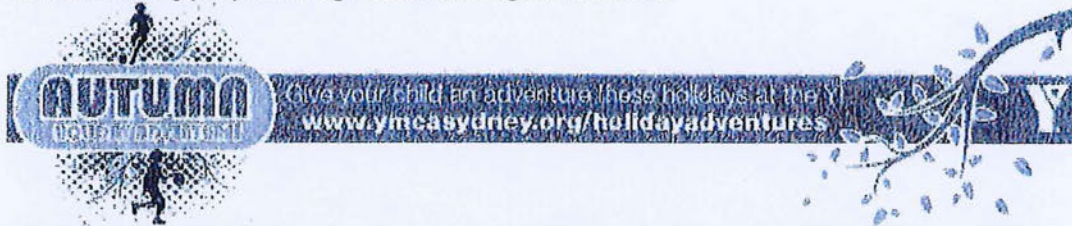
