- 25/8/09 as a casual childcare assistant working 1-3 days per week shifts at 4 BASC centres (St Pats, Lilli Pilli, Caringbah Public & Laguna St). These shifts varied and were not permanent.
- During October 09 from 19th to 30th he worked up to 4 days per week more permanently at Lilli Pilli. From Nov to Dec 09 he worked a 5 week block 5 days per week at Caringbah Public then back to Lilli Pilli 2-3 days per week until end of school term Dec 16th 09.
- Over the Dec/Jan 2009-2010 holidays up to 4 shifts per week at both St Pats and Caringbah centres.
- Commencing Feb 2010 beginning the school term he was employed as a permanent part time coordinator, 30-35 hours per week at the St Patrick's centre. He stayed at this BASC centre the entire year of 2010, however worked at both vacation care centres permanently
- Commencing 2010 he was working 1 -2 days per week in the crèche service.
- Commencing 2011 he remained at the St Pats centre for the first week of term then transferred to Caringbah Public as the coordinator.
- He remained doing 1-2 days per week working in the crèche service
- During 2011 he commenced casual school PE shifts.
