

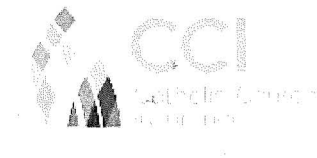

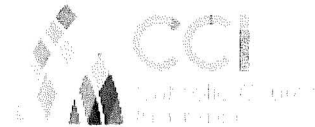
I also believe that JJ would benefit from receiving legal advice and she may wish her psychologist attend the facilitation with her. Michael Salmon would be able to discuss this with her.
