Thanks for your emails which I have just received. I have a copy of your school results and note the drop in the results after year 11 which we discussed. I also have a copy of your 2 impressive history assignments.

Following on from my High School Certificate received this afternoon.

I have attached 2 pieces of work that I have kept from 30 years ago this year.

There are two essays that I wrote for a Modern History subject where Brother Peter Rodney was my teacher. The essays are pre the Murrin incident

I would like to know why I went from being in the top 3 of the class to failing the subject in semester 2 grade 12. At no stage were any question raised either to me nor my parents.

I also believe that in relation to a TE score semester 2 in grade 12 was worth 40% of my overall score so this was not helpful.

Did not brother Peter Rodney, Gerald and Andrew have a duty to investigate why my results deteriorated following the incident with Ross Murrin

It is my belief that Peter Rodney didn't ask any question about my results as he nor Brother Gerald wanted to know the answer as I believe that they already knew.

I also do not believe that is good enough for Peter Rodney not to attend my mediation because he is on holidays.

In my mind I was the victim of a paedophile and these three were complicit at best. I think that it is the responsibility of all three of them to attend the mediation.

Also, on a wider scale I believe that the Marist brother should consider some sort of sanctions that could be levied against these three as a result of their failure to protect me!
