Count 1

Between 29 July 1969 and 29 July 1971 at Darwin in the Northern Territory of Australia, did commit buggery with

Section 71 of The Criminal Law and Consolidation Act and Ordinance.

Count 2

Between 29 July 1965 and 29 July 1967 at Darwin in the Northern Territory of Australia, indecently assaulted

Section 72 of The Criminal Law and Consolidation Act and Ordinance.

Count 3

Between 29 July 1965 and 29 July 1967 at Howard Springs in the Northern Territory of Australia, indecently assaulted

Section 72 of The Criminal Law Consolidation Act and Ordinance.



Count 4

Between 29 July 1965 and 29 July 1967 at Berry Springs in the Northern Territory of Australia, indecently assaulted

Section 72 of The Criminal Law Consolidation Act and Ordinance.

Count 5

Between 1 January 1963 and 31 December 1968 at Darwin in the Northern Territory of Australia, indecently assaulted Carmen Victoria McMahon.

Section 66 of The Criminal Law and Consolidation Act and Ordinance.

Count 6

Between 1 June 1968 and 12 June 1968 at Darwin in the Northern Territory of Australia, unlawfully assaulted Carmen Victoria McMahon with such assault occasioning actual bodily harm.

Section 40 of The Criminal Law and Consolidation Act and Ordinance.

Count 7

Between 25 May 1964 and 25 May 1966 at Darwin in the Northern Territory of Australia, indecently assaulted

Section 72 of The Criminal Law Consolidation Act and Ordinance.

Count 8

Between 25 May 1963 and 25 May 1965 at Darwin in the Northern Territory of Australia, indecently assaulted

Section 72 of The Criminal Law Consolidation Act and Ordinance.

Count 9

Between 25 May 1963 and 25 May 1966 at Darwin in the Northern Territory of Australia, indecently assaulted

Section 72 of The Criminal Law Consolidation Act and Ordinance.



Count 10

Between 25 May 1963 and 25 May 1966 at Darwin in the Northern Territory of Australia, indecently assaulted AJE

Section 72 of The Criminal Law Consolidation Act and Ordinance.

Count 11

Between 25 May 1966 and 25 May 1970 at Marrakai Station in the Northern Territory of Australia, indecently assaulted AJE

Section 72 of The Criminal Law Consolidation Act and Ordinance.

Count 12

Between 29 May 1964 and 25 May 1971 at Darwin in the Northern Territory of Australia, indecently assaulted Carmen Victoria McMahon.

Section 66 of The Criminal Law Consolidation Act and Ordinance.

Count 13

Between 29 May 1964 and 29 May 1971 at Howard Springs in the Northern Territory of Australia, indecently assaulted Carmen Victoria McMahon.

Count 14

Between 29 May 1964 and 29 May 1971 at Berry Springs in the Northern Territory of Australia, indecently assaulted Carmen Victoria McMahon.

Between 29 May 1973 and 29 May 1974 at Darwin in the Northern Territory of Australia, indecently assaulted Carmen Victoria McMahon.
