

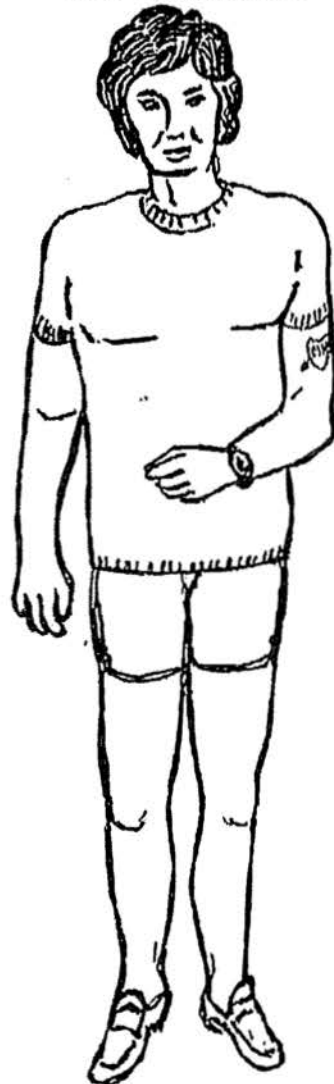

Left arm, right arm, ear, left fingers, right fingers, left foot, right foot, left hand, right hand, left leg, right leg.

Smart, untidy, shabby, dirty.
