count the number of apprehensions. If the same person were apprehended multiple times, s/he would be counted multiple times.

Counting Rules for Court outcomes for a person:

- Convicted - At least one offence in an apprehension received a punishable penalty.
- Withdrawn or Acquitted - At least one offence in an apprehension was acquitted or withdrawn and no offence received a punishable penalty.
- Proceeded but not yet finalised - no offence within in an apprehension was finalised and at least one offence was proceeded with.
- Not proceeded with - none of the offences in the apprehension were proceeded with.

Note: data entry oversight means a small proportion of offences are never formally "finalised" within the system. Hence the counting rule for "Withdrawn/acquitted" selects apprehensions where no offence has received a punishable penalty and at least one offence has been acquitted or withdrawn. In a small proportion of instances, unfinalised offences in these apprehensions may later be finalised. Hence, some persons in this category may later move to the "Convicted" category.
