Please proceed with organising the necessary medical appointments for the plaintiffs to be examined by our experts.

The 15 claims have now been rolled into one MPL number: 7300972. Please bill this matter in a single bill for all 15 plaintiffs.

I note that you were sent a number of Community Service files on 19 May 2010. Please copy these to counsel. Ms Pancia has provided a copy of these to Mr Maxwell. To date, no other Community Service files have surfaced but as you are aware I have been in contact with Mr Maxwell about the possibility of old Aboriginal Welfare Board files relating to the Gordons. We do not have an immediate right of access to these files and consideration will need to be given as to if and when we might access this information.


