*The current systems, policies or procedures in place in the Victoria Police in relation to incidents, allegations or complaints of child sexual abuse of children and young people at youth justice centres, including but not limited to:*

- a. *receiving reports of incidents, allegations or complaints of child sexual abuse;*
- b. *responding to reports of incidents, allegations or complaints of child sexual abuse;*
- c. *training in responding to reporting of incidents, allegations or complaints of child sexual abuse;*
- d. *training in interviewing and taking statements from children and young people;*
- e. *access to specialist advice or assistance within the Victorian Police (for example, general duties officers having access to advice from specialist units or squads);*
- f. *access to advice or assistance external to the Victoria Police (for example, assistance to witnesses);*
- g. *communication with children and young people in youth justice centres who are victims of child sexual abuse and communication with their guardians;*
- h. *communication with youth justice centres in relation to children and young people in youth justice centres who are victims of child sexual abuse;*
- i. *dealing with children and young people in youth justice centres who are alleged to be offenders of child sexual abuse; and*
- j. *dealing with children and young people in youth justice centres who abscond or escape from youth justice centres.*
